2. **SUBMISSIONS ON THE MINISTRY FOR THE ENVIRONMENT REPORT – “WASTE MINIMISATION IN NEW ZEALAND”, GUIDANCE FOR TERRITORIAL AUTHORITIES ON PREPARATION OF WASTE MANAGEMENT AND MINIMISATION PLANS**

3. **OI GLASS COMPANY**

Representatives of the OI Glass Company were present to advise the Committee of their glass container operation which had been operating since 1922. The plant had reached its capacity in 2002, but now was moving forward with the installation of a third glass furnace at Penrose.

The company saw the challenge was to get glass containers back for recycling within New Zealand.

The next meeting is to be held on 8 June 2009 which will take the form of a visit to MRF and the Compost Plant.
