8. YALDHURST RURAL RESIDENTS' ASSOCIATION – REQUEST FOR FUNDING

At the 7 October 2009 Community Services Committee meeting the Committee was asked to consider a request for funding from the Yaldhurst Rural Residents' Association for legal expenses related to an Environment Court appeal against Blakley Construction and Road Metals Co Ltd. The Committee's recommendation to the Board is detailed below.

DEPUTATIONS BY APPOINTMENT

1.2 Yaldhurst Rural Residents' Association – Request For Funding

Jennifer Nepton and other representatives of the Yaldhurst Rural Residents' Association were in attendance to provide information and answer questions regarding clause 7 on the Committee agenda. Ms Nepton explained the reasons for the funding application, provided details of other fundraising undertaken and asked the Committee to support the Association's request.

YALDHURST RURAL RESIDENTS' ASSOCIATION - REQUEST FOR FUNDING

The Committee's consideration was sought for a funding request from the Yaldhurst Rural Residents' Association for \$15,000 for legal expenditure related to an Environment Court appeal.

Staff Recommendation:

That the Fendalton/Waimairi Community Board decline funding to the Yaldhurst Rural Residents' Association for legal expenditure related to the Environment Court appeal.

Committee Recommendation:

That the Board not support the staff recommendation and make a grant of \$8,000 from its 2009/10 Discretionary Response Fund to the Yaldhurst Rural Residents' Association to assist it with legal fees in its appeal to the Environment Court in relation to Blackstone Quarries Limited.

At the 13 October 2009 Board meeting after a deputation by Blakley Construction and Road Metals Co Ltd the Board **decided** the following:

"Following the deputations received and further deliberations, the Board resolved:

- (a) To defer a decision on this matter until its 17 November 2009 Board meeting.
- (b) That the parties concerned be invited to meet informally with members of the Board at the Fendalton Service Centre Boardroom to facilitate a better understanding of all relevant issues prior to a decision being made with respect to the funding request.
- (c) That those Board members available to attend the meeting report back to the Board at its 17 November meeting regarding the outcome of the discussions."

The Board have received advice from staff outlining the legal position and Board powers in using discretionary monies to fund this activity, ensuring sufficient information has been provided for the Board to make a decision on this matter.

1. APPLICATION TO THE BOARD'S YOUTH DEVELOPMENT SCHEME - ASHER RICHARDSON

The Committee's recommendation was sought for a request for funding from the Board's 2009/10 Youth Development Scheme for Asher Richardson, to compete in the World Junior Badminton Championships.

COMMITTEE RECOMMENDATION

That the Board allocate \$500 to Asher Richardson towards costs of competing in the World Junior Badminton Championships.

PURPOSE OF REPORT

1. To seek the adoption by the Fendalton/Waimairi Community Board of its ordinary meeting dates from February to September 2010 inclusive.

EXECUTIVE SUMMARY

- In order that the business of the Board can be conducted in an orderly manner, and to allow public notification to be given of those meetings in compliance with the Local Government Official Information and Meetings Act 1987, it is necessary for the Board to adopt a schedule of ordinary meetings for 2010.
- 3. The next triennial Christchurch City elections will be held on Saturday 9 October 2010, and the schedule of dates therefore lists meetings from February to September inclusive. It will be for the incoming Board to decide on its governance and meeting arrangements, following the elections.
- 4. The dates proposed assume that the principal ordinary meetings of the Fendalton/Waimairi Community Board will be held, generally, in the third week of each month commencing at 4.00pm. An additional ordinary Board meeting will be held each month, primarily for the purpose of confirming the previous Board meeting minutes, prior to forwarding them to the Council. All ordinary meetings will be held in the Board Room, Fendalton Library and Service Centre, corner Jeffreys and Clyde Roads, Fendalton.
- 5. The dates proposed include the Board's Committee meetings for 2010. The Works, Traffic and Environment Committee will meet on the last Monday of each month, and the Community Services Committee on the first Wednesday of each month. The Board confirmation meeting will immediately follow the Community Services Committee meeting. The Finance and Planning Committee will continue to operate on an "as required" basis.
- 6. The schedule includes an additional ordinary meeting proposed for 4pm on Thursday 15 July 2010 to consider allocation of the Board's Strengthening Communities Funding, and also includes a meeting of the Small Grants Fund (formerly Small Projects Fund) Assessment Committee on Tuesday 17 August 2010 at 6.00pm.
- 7. The Board will also recall that week three of each calendar month is "community week" for Councillors; where as far as possible Council meetings are not scheduled during that week so that Councillors have the opportunity to be active in the community in their representation role, including for Community Board business and activities. The Board should be aware that by agreeing to the dates for its 2010 meetings as proposed in this report, some meetings fall outside week three.
