PURPOSE OF REPORT

1. The purpose of this report is to seek a resolution from the Board for funding of \$1,000 to host an opening reception for an exhibition at the Akaroa Museum.

EXECUTIVE SUMMARY

2. The *Ngai Roimata o Takapuneke* exhibition will open at the Akaroa Museum on Thursday 4 February 2010 and has been timed to coincide with the historical celebrations taking place at Takapuneke and Onuku over the following two days.
3. The exhibition commemorates the formal protection by the Christchurch City Council of Takapuneke as a local historic reserve and will attempt to promote a better understanding of why the area is so significant to Ngai Tahu and all New Zealanders. Using images text and audio interviews, the exhibition places the history of Takapuneke within the wider cultural landscape of the Akaroa Harbour. An important taonga, the *Kataore* mere (on loan from the Auckland museum) will be a focal point of the exhibition. *Kataore* comes from the Akaroa area and is thought to have belonged to the Upoko Ariki, Te Maiharanui and has not been back since it left the area.
4. Because of the significance of the exhibition, the Board's Akaroa Museum Advisory Committee wishes to co-host an opening reception with the Friends of the Akaroa Museum (FOAM). It is expected that the opening will be attended by Ngai Tahu representatives, Councillors, Community Board members, members of parliament and dignitaries from Wellington along with local community members.

FINANCIAL IMPLICATIONS

5. There are no financial implications outside existing budgets.
6. The total cost of this project is \$1,000. There is currently a balance of \$7,614 in the Board's Discretionary Response Fund (plus the \$2,000 for Youth Development).
