PURPOSE OF REPORT

1. The purpose of this report is to seek approval for an application for funding from the Board's 2009/10 Youth Development Scheme.

EXECUTIVE SUMMARY

2. The applicant is Wai Ling Chan, a 12 year old Burnside High School student living in Avonhead.
3. Wai Ling has been selected by Fencing New Zealand to compete in the Hong Kong Age Group Fencing Championships in January 2010. In addition to this Wai Ling will spend a week in Hong Kong training with the Hong Kong Junior Squad. Following this training week she will also compete in the Singapore Cadet Fencing World Cup.
4. Wai Ling has been fencing since age nine and is currently the New Zealand ranked No. 1 in the Under 15 foil and No. 2 in the Under 17 foil. Her highest international result is a third placing in the Oceania and Australian Cadet Championships 2009 held in Brisbane in July this year.
5. Wai Ling is a member of the Fencing Institute of Christchurch and trains three times per week. Her coach advises that exposure to international competition will be of huge benefit to her development in this sport.

FINANCIAL IMPLICATIONS

6. The total cost per person to attend the tournament is \$4,300 which includes air fares, accommodation, uniforms and tournament entrance fee.
7. Wai Ling and her family have been fundraising doing sausages sizzles.
8. This is the first time the applicant has applied to the Board for financial support.

PURPOSE OF REPORT

1. The purpose of this report is to seek approval for an application for funding from the Board's 2009/10 Youth Development Scheme.

EXECUTIVE SUMMARY

2. The applicant is Kimberley Robson, a 19 year old Canterbury University student living in Burnside.
3. Kimberley is a New Zealand Senior International Rhythmic Gymnast. She is seeking support to help in her endeavour to qualify and compete for New Zealand at the 2010 Commonwealth Games.
4. In May and June 2009, Kimberley travelled to Europe to compete in 3 competitions - The Chodov Cup in Prague, the Mol Cup in Belgium, and the Baltic Cup in Poland. She placed ninth in Prague, fifth in Belgium, where she made two finals and placed fourth in the hoop final, and twenty-first in Poland.
5. Kimberley is currently midway through a two month period of intensive training in Russia.
6. The funding requested is towards the cost of competing in two international competitions. The first is in Los Angeles from 22 - 24 January 2010, and from there she will travel to Montreal to represent New Zealand in a World Cup competition on 29 - 31 January 2010. Kimberley will be travelling direct from Russia to compete in these tournaments.
7. In order to be considered for selection for the Commonwealth Games, Kimberley is required to compete in both of these competitions.

FINANCIAL IMPLICATIONS

8. The total cost for Kimberley to travel from Russia to compete in the two tournaments is \$9,000 which includes air fares, accommodation, food, uniforms and tournament entrance fee.
9. Kimberley works part time and has organised an auction which raised \$2,000.
10. This is the second time the applicant has applied to the Board for financial support. Kimberley was successful in receiving \$400 from the Board in March 2007 towards competing in a gymnastics competition in Portugal. She achieved... in this competition..??
