#### 1. DEPUTATIONS BY APPOINTMENT

## 1.1 Dr Ruth Parkyn – Daresbury Park Tree Removal and Planting Plan

Dr Ruth Parkyn was in attendance and spoke to the Committee in support of the proposed tree removal and maintenance work at Daresbury Park.

## 1.2 Grant Moreton – Daresbury Park Tree Removal and Planting Plan

Mr Grant Moreton was in attendance and spoke to the Committee in opposition to the proposed tree removal and maintenance work at Daresbury Park. Mr Moreton also tabled a report from an independent Arborist in support of his objection.

## 2.1 Jennie Hamilton – Wroxton Terrace Street Renewal Update

Further to clauses 1.1 and 1.2, the Committee considered a report seeking a recommendation to the Board regarding the Daresbury Park Tree Removal and Planting Plan.

## **COMMITTEE RECOMMENDATION**

That the Board resolve to approve the Daresbury Park Tree Removal and Planting Plan. (LP314301 L04) for implementation subject to:

- (i) a reconsideration by staff of the intention to remove and dispose of the five current magnolia trees and
- (ii) that the magnolia trees be moved either to more suitable positions within Daresbury Park or relocated elsewhere within the Fendalton area.
