PURPOSE OF REPORT

1. The purpose of this report is to seek approval for an application for funding from the Riccarton/Wigram 2009/10 Youth Development Scheme.

EXECUTIVE SUMMARY

2. The applicant, Jayvee Tabanas Buchanan, is an 18 year old Riccarton resident and is seeking Community Board support to travel to Whitianga to attend an Optimist sailing clinic to prepare for the upcoming Optimist Nationals and International Selection Regatta. This trip will take place from 27-31 March 2010.
3. Jayvee started sailing at the age of eight and has continually improved in his sport. He has contested numerous optimist open class championships, five national and four international regattas. Jayvee has also attained respectable results recently at regional, South Island and National P Class competitions, including National P Class Champion and Tauranga Cup holder. In December 2009, Jayvee was awarded the Sir Peter Blake Memorial Trophy following his win in the Sir Peter Blake Memorial Regatta. This was selected across all classes at the regatta consisting of 420 contestants.
4. The upcoming clinic has been designed to help potential elite Optimist sailors achieve their goals by training together under the guidance of New Zealand's World Coach. The New Zealand Nationals is a selection regatta where only the top five competitors are selected to compete.
5. Owing to the high costs involved in the sport of sailing, Jayvee is continually fund raising and has raised \$320 to date and would appreciate any financial assistance from the Community Board.
