PURPOSE OF REPORT

1. The purpose of this report is to seek approval for an application for funding from the Riccarton/Wigram 2009/10 Youth Development Scheme.

EXECUTIVE SUMMARY

- 2. The applicant, Richie Ballantyne Mo'unga, is a 15 year old who lives in Upper Riccarton and is seeking Community Board support to compete for Canterbury in the U21 Men's National Touch Tournament in Auckland. This trip will take place from 3 to 7 March 2010.
- 3. Richie is a talented sportsman playing and competing in several sporting codes, but his main passion is Rugby Union, which he has been playing for nine years. Richie is currently a scholarship holder for rugby at St Andrews College. Richie is also a member of the St Andrews College Senior A Volleyball team and a member of the St Andrews College Senior Mixed Touch team, which was placed third at the 2009 Nationals.
- 4. This year's National Touch Tournament will have over 45 teams from throughout New Zealand competing in Men's, Women's and Mixed Grades, from Under 19 to Over 45. The tournament provides Richie with the opportunity to play at an elite level and to have the opportunity to learn and develop skills from other teams and players attending the tournament.
- 5. Richie's family are supportive of his many sporting opportunities, and he will be fundraising for his trip through raffles to assist with his expenses. To date he has raised \$100 for his trip and any financial assistance would be greatly appreciated.
