PURPOSE OF REPORT

1. The purpose of this report is to seek approval for an application for funding from the Hagley/Ferrymead Community Board 2010/11 Youth Development Scheme.

EXECUTIVE SUMMARY

- 2. The applicant, Aidan Imogene Charlotte Verity is a 17 year old resident of Richmond seeking support to go on tour with the Christchurch Youth Orchestra to Australia in December 2010.
- 3. The Christchurch Youth Orchestra is Christchurch's top orchestra for young people aged 15 to 25 and is run through the Christchurch School of Music. Aidan has been a member of the Christchurch Youth Orchestra since 2008. She has toured in the South Island including Stewart Island, Waimate, Twizel and Mt Cook. She is also a member of the St Margaret's College orchestra. Aidan plays the viola and has been having lessons for seven years. She also likes composing and a fanfare that she has written has been performed in one of their concerts.
- 4. Aidan also began playing the saxophone in 2009. She goes to YROC, the youth group at Rutland Street Church each week and plays in the youth band and Sunday group occasionally. This year Aidan took part in sport aerobics and came third in a regional competition. Her Chamber music group has played for two cancer charity events and plays at school events on a regular basis.
- 5. Aidan is really looking forward to going on tour to Australia where they will give indoor and outdoor concerts with the Sydney Youth Orchestra in Sydney and in rural towns Singleton, Gulgong, Mudgee and Dubbo where residents do not usually have the pleasure of seeing a full symphony orchestra play. They will also be visiting primary schools and giving workshops, showing the children the different instruments which is rewarding for both performers and children.

FINANCIAL IMPLICATIONS

6. The total cost per person is \$1,860. Fundraising so far includes putting on two zumba classes, concerts in the Christchurch Cathedral, a toddlers' prom and a quiz night that was cancelled due to the earthquake but will still go ahead at a later date. Any financial assistance will be greatly appreciated.

PURPOSE OF REPORT

1. The purpose of this report is to seek approval for an application for funding from the Hagley/Ferrymead Community Board 2010/11 Youth Development Scheme.

EXECUTIVE SUMMARY

- 2. The applicant, Javaan Ariona Togiaso is a 15 year resident of Linwood seeking support to develop his Rugby League Skills at a training camp for boys aged 12 to 16 years old with the Manly Rugby League Club in Sydney in January 2011.
- 3. Javaan has been playing league for four years. He plays for the Celebration Lions and also Shirley Boys High School. He also plays volleyball for Canterbury, social touch and enjoys spending quality time with family and friends.
- 4. For three years Javaan has represented Canterbury in his chosen sport. He has also been awarded Overall Junior Sports Award in 2007; Best Forward of the Year in 2008 and 2009 and Man of the Match Grand Final Game in 2010 for his club Celebration Lions.
- 5. Javaan is one of five junior players selected by Canterbury Rugby League to attend the training camp from Canterbury. The training camp runs for four days followed by extra training opportunities with specialist coaches after the camp and the opportunity to watch and meet NRL teams train. Throughout the duration of the camp, players will follow a carefully balanced program designed to promote skill development, sportsmanship, fun and enjoyment.
- 6. All players are fully supervised throughout the duration of the camp by trained NSWRL Staff and Academy of Sport Staff. Both Javaan and his coaches consider this to be a tremendous opportunity for Javaan to train alongside some top NRL league players from the Manly Sea Eagles Team and to pursue his chosen sport as a possible career choice alongside wanting to join the Police. Javaan and his family are also keen to be involved in community events such as LYFE.

FINANCIAL IMPLICATIONS

7. The total cost for Javaan is \$1,380. Fundraising for the training camp is underway. \$400 has been raised so far with a Family Lotto Bonus Number Fundraiser. Javaan is a deserving applicant and support from the Board would provide significant assistance.

PURPOSE OF REPORT

EXECUTIVE SUMMARY

- 2. Christchurch Community Boards are located in Zone 5 of Local Government New Zealand's areas of representation. Yvonne Palmer (former Chair and member of the Shirley/Papanui Community Board) is currently the Zone 5 Representative. Mike Mora is the current Zone 5 Deputy Representative.
- 3. The Executive Committee is made up of six representatives one for each of the six geographic zones of member authorities throughout New Zealand and has the status of an advisory committee to the National Council of Local Government New Zealand.
- 4. The Executive Committee meets four times a year, usually in Wellington and its role involves:
 - 1. Providing advice to the National Council of Local Government New Zealand on all matters involving Community Boards.
 - 2. Liaising between Local Government New Zealand and Community Boards to gather information on issues and matters of national interest.
 - 3. Keeping National Council of Local Government New Zealand informed of current and future issues of concern to Community Boards that may have implications for local government generally.
 - 4. Advising on training needs of Community Boards and their members that might be included in a national capacity building strategy.
- 5. Supporting information setting out the guidelines for the conduct of the election is **attached**.
- 6. It is proposed that Community Board Chairs discuss the issue of Zone 5 representation at their first meeting in December 2010 with a view to agreeing on a Zone 5 Representative and Deputy, after receiving feedback from members of their respective Boards on this issue.

- 7. From time to time there may be costs associated with travel and accommodation for attendance at Zone 5 meetings. These costs will be minimal and can be absorbed within the budgets for elected member representation as outlined on page 159 of the LTCCP.
