PURPOSE OF REPORT

1. The purpose of this report is to seek approval from the Board to set aside \$10,000 from its 2011/12 Discretionary Response Fund for the purpose of establishing a Youth Development Scheme.

EXECUTIVE SUMMARY

- 2. The purpose of the Youth Development Scheme is to celebrate and support young people living in the Shirley/Papanui ward by providing financial assistance for their development. The Community Board also seeks to acknowledge young people's effort, achievement and potential excellence in the community.
- 3. The Youth Development Scheme will consider applications for the following activities:

Personal Development and Growth - For example leadership training, Outward Bound, Spirit of Adventure, extra curricular educational opportunities.

Representation at Events - Applicants can apply for assistance if they have been selected to represent a school, team or community at a local, national or international event or competition. This includes sporting, cultural and community events.

- 4. The Board has determined that the following eligibility criteria must be met:
 - Age groups 12-25 years.
 - Projects must have obvious benefits for the young person and if possible the wider community.
 - Only one application permitted per year.
 - Applicants should be undertaking other fundraising activities and not relying solely on Community Board support.
 - Successful applicants will be required to report back on their experiences to the Community Board.
- 5. Each application will be assessed by the appropriate staff member and presented to the Board for its consideration.

FINANCIAL IMPLICATIONS

6. This proposal transfers funds from the Board's Discretionary Response Fund into a separate Youth Development Scheme fund. This reduces the total amount available in the Board's Discretionary Response Fund in 2011/12 by \$10,000. The current balance of the Discretionary Response Fund is \$47,897.

The Community Board also seeks to acknowledge young people's effort, achievement and potential excellence in the community.
- 4. The Youth Development Scheme will consider applications for the following activities:

Personal Development and Growth - For example leadership training, career development, Outward Bound, Spirit of Adventure, extra curricular educational opportunities.

Representation at Events - Applicants can apply for assistance if you have been selected to represent your school, team or community at a local, national or international event or competition. This includes sporting, cultural and community events.

- 5. The following eligibility criteria must be met:
 - Age groups 12-25 years.
 - Projects must have obvious benefits for the young person and if possible the wider community.

9. RADCLIFFE ROAD PROPOSED NO STOPPING

PURPOSE OF REPORT

1. The purpose of this report is to seek the Board's approval that the stopping of vehicles be prohibited at any time along the north side of Radcliffe Road adjacent to the main vehicle entrance to the Northwood Supa Centa.

EXECUTIVE SUMMARY

- 2. Staff have received a request from users of Northwood Supa Centa to install no stopping restrictions on Radcliffe Road adjacent to the main vehicle entrance to Northland Supa Centa. Site inspections have confirmed that when vehicles are parked within the edge line taper at the entrances, the sight lines along Radcliffe Road are inadequate (refer **attachment 1**).
- 3. Radcliffe Road is a local road and links Main North Road and Marshland Road, via Hawkins Road. There are three vehicle crossings to Northwood Supa Centa along Radcliffe Road. These vehicle crossings generate many vehicle movements as shoppers access the carpark and businesses. The Supa Centa is increasing in popularity, which is likely to increase vehicle movements. The middle entrance is the main entrance off Radcliffe Road into the Northwood Supa Centa carpark. Between the western and middle entrances there are edge markings showing the parking area but there are no 'no stopping' restrictions along this section of Radcliffe Road. To further enforce the parking space along this section staff are proposing the installation of no stopping restrictions at the corners of the crossings.
- 4. It is acknowledge that these vehicle crossings provide access to private property and typically staff would not support the installation of no stopping restrictions adjacent to such access points. However in this case the access points are formed as road intersections and accommodate reasonably high vehicle movements such that an exception is considered warranted.
- 5. No consultation was undertaken for this scheme. This is seen as a safety measure and the installation of no stopping restrictions along Radcliffe Road does not directly affect residential properties as there is no frontage along this section. The Northwood Supa Centa owners have been informed of this proposal and did not comment.

FINANCIAL IMPLICATIONS

6. The estimated cost of this proposal is approximately \$75.

7. The installation of road markings and signs is within the LTCCP Streets and Transport Operational Budgets.

LEGAL CONSIDERATIONS

- 8. Part 1, Clause 5 of the Christchurch City Council Traffic and Parking Bylaw 2008 provides Council with the authority to install parking restrictions by resolution.
- 9. The Community Boards have delegated authority from the Council to exercise the delegations as set out in the Register of Delegations. The list of delegations for the Community Boards includes the resolution of parking restrictions.
- 10. The installation of any parking restriction signs and/ or markings must comply with the Land Transport Rule: Traffic Control Devices 2004.

- (b) That the stopping of vehicles be prohibited at any time on the north side of Radcliffe Road commencing at a point 145.5 metres from the centre line of the railway lines and extending in a westerly direction for a distance of 13 metres.

 - Representation at Events Applicants can apply for assistance if you have been selected to represent your school, team or community at a local, national or international event or competition. This includes sporting, cultural and community events.
- 5. The following eligibility criteria must be met:
 - Age groups 12-25 years.
 - Projects must have obvious benefits for the young person and if possible the wider community.
 - Only one application per person permitted per year.
 - Applicants should be undertaking other fundraising activities and not relying solely on Community Board support.
- 6. The applicant is Abbey Chambers an 18 year old, who lives in Freebairn Street, Redwood. Abbey is seeking funds to assist with completing an Internship at Attunga Christian Camp in New South Wales.
- 7. Abbey attends Papanui Baptist Church and is a leader with a number of youth and children's groups including: Rock Solid, the Northcote School Breakfast Club, Papanui Pirates Holiday Programme. She also volunteers at the Kimi Ora Unit at Papanui High School and at Te Koru Pou Iho Youth Centre.
- 8. This Internship focuses on developing life skills and leadership. Abbey sees this as an opportunity to lead into Youth Work which she intends to pursue in Christchurch in 2012.
- 9. Abbey has already completed Semester 1 of the Internship. Semester 2 runs from 14 August to 21 December 2011.
- 10. A reference from the Assistant Pastor at Papanui Baptist Church recommends Abbey as "an honest, reliable and conscientious person".
- 11. Abbey is one of seven siblings and from a family that has little financial resources. She has undertaken a number of personal fundraising activities and continuing with others. She has run a youth event, held a raffle and sells items on Trade Me. So far, this has raised around \$1,500.

FINANCIAL IMPLICATIONS

- 12. The total cost of completing the second semester is \$4,150, made up of semester fees of \$3,850 and airfares of \$300.
- 13. The Shirley/Papanui Community Board currently has a balance of \$47,897 in the 2011/12 Discretionary Response Fund
