## 8. MONCKS SPUR / MT PLEASANT ROAD GIVE WAY CONTROL

#### PURPOSE OF REPORT

1. The purpose of this report is to seek the Hagley/Ferrymead Community Board approval to install a Give Way Control on Moncks Spur Road at its intersection with Mt Pleasant Road.

#### EXECUTIVE SUMMARY

- 2. Following concerns raised by members of the public, staff carried out a study of the intersection of Moncks Spur Road and Mt Pleasant Road (refer Attachment 1). It was found that the concerns raised are valid in that there is confusion about the right of way at the intersection. This confusion arises for motorists on Moncks Spur Road while travelling uphill (southwest bound) due to the vertical and horizontal alignment changes. While the intersection is a T intersection where normal priority rules apply, some motorists travelling uphill (southwest bound) from Moncks Spur Road and then downhill onto Mt Pleasant Road (southwest bound) genuinely believe they are on the through route. They also believe that Mt Pleasant Road uphill (northeast bound) and downhill (southwest bound) approaching traffic is required to turn at the intersection (hence give way to Moncks Spur Road traffic) to continue on Mt Pleasant Road through the intersection.
- 3. The effect of this has been near miss incidents where uphill (northeast bound) Mt Pleasant Road motorists, who know they have right of way, nearly collide with Moncks Spur Road (southwest bound) motorists, who wrongly believe they have right of way.
- 4. A Give Way control on the Moncks Spur Road approach will clarify this confusing right of way issue.

#### FINANCIAL IMPLICATIONS

5. The estimated cost of this proposal is approximately \$700.

6. The installation of road markings and signs is within the LTCCP Streets and Transport Operational Budgets.

- 7. Part 1, Clause 5 of the Christchurch City Council Traffic and Parking Bylaw 2008 provides the Council with the authority to install parking restriction and traffic controls, by resolution.
- 8. The Community Boards have delegated authority from the Council to exercise the delegations as set out in the Register of Delegations. The list of delegations for the Community Boards includes the resolution of parking restrictions and traffic control devices.
- 9. The installation of any signs and/ or markings associated with traffic control devices must comply with the Land Transport Rule: Traffic Control Devices 2004.
