PURPOSE OF REPORT

- 1. The purpose of this report is for the Riccarton Wigram Community Board to consider two applications for funding from its 2011/12 Discretionary Response Fund from:
 - (a) Ilam School for the 'Tournament of Minds' competition.
 - (b) Community Development Network Trust (CDN) for the operation of the Wycola Teen Hang Out.

EXECUTIVE SUMMARY

- 2. In 2011/12, the total pool available for allocation for the Riccarton Wigram Discretionary Response Fund is \$72,491. The Discretionary Response Fund opens each year on 1 July and closes on 30 June the following year, or when all funds are expended.
- 3. The purpose of the fund is to assist community groups where the project and funding request fall outside other council funding criteria and/or closing dates. This fund is also for emergency funding for unforeseen situations.
- 4. At the Council meeting of 22 April 2010, the Council resolved to change the criteria and delegations around the local Discretionary Response Fund.
- 5. The change in criteria limited the items that the local Discretionary Response Fund does not cover to only:
 - (a) Legal challenges or Environment Court challenges against the Council, Council Controlled Organisations or Community Boards decisions;
 - (b) Projects or initiatives that change the scope of a Council project; and
 - (c) Projects or initiatives that will lead to ongoing operational costs to the Council.

The Council also made a note that: "Community Boards can recommend to the Council for consideration grants under (b) and (c)."

- 6. Based on these criteria, the applications from Ilam School and Community Development Network Trust are eligible for funding.
- 7. Detailed information on the applications and staff comments are included in the attached Decision Matrix. (Attachment 1).

FINANCIAL IMPLICATIONS

8. There is currently \$37,501 remaining in the Board's 2011/12 Discretionary Response Fund.

PURPOSE OF REPORT

1. The purpose of this report is to seek Community Board approval for an application for funding from the 2011/12 Youth Development Scheme.

EXECUTIVE SUMMARY

- 2. The applicant, Emily Abbey Shields, is an 18 year old Upper Riccarton resident and is seeking Community Board support to travel to Sydney to study the performing arts at the ED5 dance school. This trip will take place from January to December 2012.
- 3. Emily has been dancing for 14 years and singing and acting for 10 years and is trained in various dance styles and theatrically and classically voice trained. Emily has performed in events and productions such as Starry Nights, Christmas in the Park, Festival of Flowers, Joseph and the Amazing Technicolour Dream Coat, Grease, High School Musical, and Fiddler on the Roof. Emily was also heavily involved in music and drama while at Burnside High School for five years and she now wishes to pursue her passion for the performing arts at the highest level possible.
- 4. Emily auditioned for three dance schools in Australia and was accepted into the Ministry of Dance course at ED5 in Sydney recently. She has also been called back for a second audition in Melbourne for the WAAPA dance school in November.
- 5. The cost of attending these courses is extremely high with the ED5 two year course costing \$20,000 and if she was to be accepted into the WAAPA course that would cost \$15,000 for three years. Prior to the earthquake Emily was working to earn money for her study, but unfortunately lost her job following the earthquake and since then she has been busking and applying to other funding sources to raise funds.
- 6. On top of her course costs, Emily will also have living expenses to pay for and although she will continue to fundraise before she leaves; she would appreciate any assistance from the Community Board.

PURPOSE OF REPORT

1. The purpose of this report is to consider an additional application for Neighbourhood Week 2011 funding.

EXECUTIVE SUMMARY

- 2. Local community groups, including residents' associations and neighbourhood support groups will be sent information inviting them to apply for the Neighbourhood Week Funding that has been set aside by the Board.
- 3. Neighbourhood Week is a dedicated week in which individuals and groups are encouraged to get together and get to know one another locally. Neighbourhood Week 2011 is to be held from 29 October to 6 November 2011. Applications for funding closed on 9 September 2011.
- 4. The Riccarton/Wigram Community Board considered applications at the 18 October 2011 Community Board Meeting. Unfortunately one application was omitted from the matrix of applications for consideration and it is that application that is the subject of this report. The application was submitted on time.
- 5. The application for consideration is from Mr Tony Stewart who has applied for \$225 for an event to be held in Garforth Green, Halswell. The total cost of the event is \$325. He expects 50+ people to attend the event.
- 6. Based on what was recommended and funded for other events, staff are recommending funding \$200 towards this event.

FINANCIAL IMPLICATIONS

7. The Board allocated \$4,460 towards events from the \$5,000 it had set aside from the Strengthening Communities Fund to assist individuals and groups run events.
