# 10. EASEMENT FOR SEWER PIPE OVER MARYLANDS RESERVE

#### **PURPOSE OF REPORT**

 The purpose of this report is to seek the Community Board's approval to the granting of an easement to the Council for the right to convey sewage in gross over part of Marylands Reserve, forming Part Rural Section 488 and Part Lot 2 DP18554.

# **EXECUTIVE SUMMARY**

- 2. The Western Interceptor sewer is being constructed to connect Matipo Street to Wigram Road thereby providing a sewer outfall that will allow development of the South West Area.
- 3. A number of alignments were considered but the preferred option through Marylands Reserve was chosen for both economic reasons and as it creates the least disruption to the surrounding commercial area. The alignment is illustrated on the plan as **Attachment 1**
- 4. The land that Marylands Reserve forms part of was originally acquired for the Christchurch Southern Motorway and is therefore Crown derived. The control of the Reserve was later vested in the Council to be administered under the Reserves Act 1977. Crown (New Zealand Transport Agency) consent has already been obtained for the easement alignment and biofilter location.
- 5. Due to the urgency of the works, the public notification process referred to in point 10 below has been initiated in order to expedite the Department of Conservation (DOC) approval process.
- 6. Approval is therefore sought for the creation of an easement to convey sewage in gross over the above stated land for the benefit of the Council as shown on the plan as **Attachment 1**

# FINANCIAL IMPLICATIONS

7. The land in question is administered by the Council but is not owned by it. The easement will therefore be valued by an Independent Registered Valuer in accordance with the provisions of the Public Works Act and compensation paid to the Crown for the benefit thereof.

# Do the Recommendations of this Report Align with 2009-19 LTCCP budgets?

8. Not applicable. The works budget for the related works will form part of the Infrastructure Rebuild Programme.

# **LEGAL CONSIDERATIONS**

# Have you considered the legal implications of the issue under consideration?

- 9. Procedurally an easement is required to create proper and accurate land title records and legally protect the infrastructure.
- 10. Provision exists under Section 48 of the Reserves Act 1977 to grant such easements. Whilst the pipeline component of the easement will not materially affect the reserve and need not be publicly notified, the biofilter will affect the use of the park and must therefore be publicly notified in accordance with the Act. Given the urgency of this matter the public notification process has already been instigated whilst the Legal Services Unit will be involved in the final documentation of the easement.
- New Zealand Transport Agency's (NZTA) standard easement instrument will be completed and registered at Land Information New Zealand once the works have been completed and a survey completed.
- 12. Community Boards have the delegated authority to grant easements over reserves.

# ALIGNMENT WITH LTCCP AND ACTIVITY MANAGEMENT PLANS

15. As the reserve will be materially altered by construction of the biofilter, public notification is required in accordance with Sections 119 and 120 of the Reserves Act 1977, which stipulates providing a period of one month for objections to be received with a right for objectors to be heard.

# STAFF RECOMMENDATION

It is recommended that the Spreydon/Heathcote Community Board:

- (a) Approve an easement in gross to convey sewage as shown on **Attachment 1** over the land forming Part Rural Section 488 and Part Lot 2 DP18554, also known as Marylands Reserve, subject to the following conditions:
  - (i) The restoration of the Reserve to the condition it was in prior to the commencement of the works with respect to the pipeline.
  - (ii) The Unit Manager Corporate Support being authorised to finalise and conclude the granting of the easement including payment of compensation for the benefit of the easement determined by an Independent Registered Valuer.
  - (iii) Concluding public notification in accordance with sections 119 and 120 of the Reserves Act 1977.
  - (iv) That a hearings panel be appointed with delegated authority to hear and determine in accordance with Section 120 of the Reserves Act 1977 any objection received by the Council in respect of the proposed works following public notification.
  - (v) The consent of the Department of Conservation being obtained.

# **PURPOSE OF REPORT**

1. The purpose of this report is to seek the Spreydon/Heathcote Community Board's approval for interested members to attend a Local Government New Zealand "Know How" Training Workshop – Financial Governance 2012, to be held in Christchurch on 3 August 2012.

# **EXECUTIVE SUMMARY**

- 2. Following on from Financial Governance 1011, this one-day Local Government New Zealand workshop aims to give elected members a deeper understanding of reporting requirements, treasury management and asset management, and explores how they impact on financial decisions.
- 3. The workshop aims to delve into the intricacies of local government finances in this detailed examination of financials and reporting. Armed with greater knowledge of the financial options available, it is expected that elected members can make even better financial decisions.
- 4. The focus in this workshop is on attendees own questions around financial governance. Issues will be discussed, with the workshop developing and tailoring solutions around relevant subjects, using case studies to examine key areas in more depth. 'Real life scenarios' will be used to debate and practice making decisions.
- 5. Topics include:
  - International financial reporting standards
  - Different available financial options
  - Financial decision making
  - Treasury Management
  - Reporting
- 6. The Council is hosting this workshop, which only entails providing a venue at Civic Offices. Elected members from other Councils will also be attending.

# FINANCIAL IMPLICATIONS

#### PURPOSE OF REPORT

1. The purpose of this report is for the Spreydon/Heathcote Community Board to consider whether they wish to recommend any Key Local Projects to the Metropolitan Strengthening Communities Fund for 2012/13.

#### **EXECUTIVE SUMMARY**

- 2. In a Board Workshop, held on 18 May 2012, the Spreydon/Heathcote Community Board considered the matter of Key Local Projects for 2012/13.
- As part of the Strengthening Communities Grants Funding Programme, each Board may nominate Key Local Projects (KLPs) in its area that are put forward to the Metropolitan Funding Committee for consideration for metropolitan funding.
- 4. The Metropolitan Funding Committee will make KLP decisions based on affordability and the following priorities:
  - Strengthening Communities Strategy Principles and Goals;
  - Funding outcomes and priorities as set out in Strengthening Communities Strategy;
  - Alignment to local Community Board objectives; AND
  - Projects deliver benefits to the city outside of the local Board area;
  - Key community issues contemplated under Goal 2 of the Strengthening Communities Strategy.
- 5. In addition, staff recommendations for Key Local Projects are also based on whether the project meets the following criteria:
  - The organisation undertaking the project has a proven track record with the Council in providing a high quality level of service;
  - Significantly contributes towards the Council's Funding Outcomes and Priorities;
  - Demonstrates leadership and innovation;
  - Demonstrates best-practice and collaboration.
- 6. Previous KLPs for this Community Board are:

9. In a Board Workshop held on 18 May 2012, staff recommended that the Board consider three KLPs. The Board requested that an application by Cross Over Trust also be considered as a KLP. Staff advised that they had recommended a grant of \$31,500 following the assessment of the Cross Over Trust application for the Boards SCF. The Board asked to have Cross Over Trust's SCF application considered as a KLP at the requested amount of \$53,000.

# **Timeline and Process**

10. KLPs that are approved by the Board will be put forward to the Metropolitan Strengthening Communities Funding Committee for consideration at its meeting on 20 July 2012. Unsuccessful KLPs are returned to the Community Board for consideration under the local Strengthening Communities Fund.

### FINANCIAL IMPLICATIONS

11. In 2012/13, the draft annual plan includes \$238,918 for the Spreydon/Heathcote Community Board Strengthening Communities Fund.

## STAFF RECOMMENDATION

It is recommended that the Spreydon/Heathcote Community Board nominate:

- a) Te Whare Roopu O Oterepo Waltham Community Cottage as a Key Local Project and recommend a grant of \$40,000 from the Metropolitan Funding Committee 2012-13 for the Strengthening Communities Fund.
- b) Rowley Resource Centre as a Key Local Project and recommend a grant of \$59,900 from the Metropolitan Funding Committee 2012-13 for the Strengthening Communities Fund.
- c) Spreydon Youth Community Trust as a Key Local Project and recommend a grant of \$38,000 from the Metropolitan Funding Committee 2012-13 for the Strengthening Communities Fund.
- d) Cross Over Trust as a Key Local Project and recommend a grant of \$53,000 from the Metropolitan Funding Committee 2012-13 for the Strengthening Communities Fund.

# **BACKGROUND**

- 17. In October 2007, the Council adopted the Strengthening Communities Fund operational procedures, which included the process for nominating Key Local Organisations (KLOs), subsequently renamed Key Local Projects (KLPs).
- 18. Each Board may nominate (KLPs) in its area that are put forward to the Metropolitan Funding Committee for consideration for metropolitan funding.
- 19. The agreed process to determine if a "local" funding application should be processed as a KLP is detailed as bullet point 16 in the report that was adopted by the Council on 4 October, 2007:

The Metropolitan Funding Committee will make KLP decisions based on affordability and the following priorities:

- Strengthening Communities Strategy Principles and Goals;
- Funding outcomes and priorities as set out in Strengthening Communities Strategy;
- Alignment to local Community Board objectives;

# AND

- Projects deliver benefits to the city outside of the local Board area
- Key community issues contemplated under Goal 2 of the Strengthening Communities Strategy.
- 20. The process for considering KLPs is as follows:
  - Community Boards nominate and prioritise their KLPs and make a recommendation to the Metropolitan Funding Committee.
  - ii) The Metropolitan Funding Committee makes decisions on Board recommended KLPs.
  - iii) Successful KLPs are allocated funding from the Metropolitan Strengthening Communities
  - iv) Unsuccessful KLPs are returned to the Community Board for consideration under the local Strengthening Communities Fund.

- 21. Community Boards are advised that where candidates for KLP funding consideration are successful in receiving funding from the Metropolitan Funding Committee, then there can be no further funding call on the Board for that project.
- 22. This is also the case, where a successful candidate is funded to a lower level than has been recommended by the Board. This reflects the "funding constraints" criteria agreed by the Council in Appendix F of the 4 October 2007 report which states that "Groups receiving funding at a Metropolitan level may only receive local level funding if the project is specifically local and no portion of it has been funded at the Metropolitan level".
