### BACKGROUND

#### STRENGTHENING COMMUNITIES STRATEGY

- 11. The Council adopted the Strengthening Communities Strategy on 12 July 2007. The Strengthening Communities Grants Funding Programme comprises four funding schemes:
  - (a) Strengthening Communities Fund
  - (b) Small Grants Fund
  - (c) Discretionary Response Fund
  - (d) Community Organisations Loan Scheme.
- 12. The following funding outcomes have been used to evaluate and assess applications to the Strengthening Communities Fund:
  - Support, develop and promote the capacity and sustainability of community recreation, sports, arts, heritage and environment groups
  - Increase participation in and awareness of community, recreation, sports, arts, heritage and environment groups, programmes and local events
  - Increase community engagement in local decision making
  - Enhance community and neighbourhood safety
  - Provide community based programmes which enhance basic life skills
  - Reduce or overcome barriers to participation
  - Foster collaborative responses to areas of identified need.
- 13. The following funding priorities have been taken into consideration when assessing applications:
  - Older Adults
  - Children and Youth
  - People with Disabilities
  - Ethnic and Culturally Diverse Groups
  - Disadvantaged and/or Socially Excluded
  - Capacity of Community Organisations
  - Civic Engagement.

### **TIMELINE AND PROCESS**

- 14. Community Boards have delegated authority from the Council to make final decisions on the Strengthening Communities Funding for their respective wards. The Board's decisions will be actioned immediately following the decision meeting.
- 15. All funding approved is for the period of September to August each year, therefore grants will be paid out in early September 2012.

#### PURPOSE OF REPORT

1. The purpose of this report is for the Spreydon/Heathcote Community Board to consider an application for funding from its 2011/12 Discretionary Response Fund from Addington Action for \$8,000 towards the running costs of the project vehicle.

### **EXECUTIVE SUMMARY**

- 2. In 2011/12, the total budget available for allocation in the Spreydon/Heathcote Discretionary Response Fund is \$51,197. Further funding of \$15,172 has been added to this amount as a result of an under spend from the Metropolitan Small Grants Fund. The Discretionary Response Fund opens each year on 1 July and closes on 30 June the following year, or when all funds are expended.
- 3. The purpose of the fund is to assist community groups where the project and funding request falls outside other council funding criteria and/or closing dates. This fund is also for emergency funding for unforeseen situations.
- 4. At the Council meeting of 22 April 2010, Council resolved to change the criteria and delegations around the local Discretionary Response Fund.
- 5. The change in criteria limited the items that the local Discretionary Response Fund does not cover to only:
  - (a) legal challenges or Environment Court challenges against the Council, Council Controlled Organisations or Community Boards decisions;
  - (b) projects or initiatives that change the scope of a Council project; and
  - (c) projects or initiatives that will lead to ongoing operational costs to the Council.

Council also made a note that: "Community Boards can recommend to the Council for consideration grants under (b) and (c)."

- 6. Based on this criteria, the application from Addington Action for Addington Action is eligible for funding.
- Detailed information on the application and staff comments are included in the attached Decision Matrix.

### FINANCIAL IMPLICATIONS

8. There is currently \$42,663 remaining in the Board's 2011/12 Discretionary Response Fund.

### PURPOSE OF REPORT

1. The purpose of this report is to present to the Board an application for funding assistance from the Spreydon/Heathcote 2011/12 Youth Achievement Scheme Fund.

### **EXECUTIVE SUMMARY**

- 2. Funding is being sought by Cameron James, 17 years old from St Martins, to compete in the New Zealand Open Swimming Championships in Auckland from 25 to 30 March 2012.
- 3. The following table details event expenses and funding requested by the applicant.

Cameron applied for \$500 from the 2010/11 Spreydon/Heathcote Youth Achievement Scheme to attend the Australian Championships but he withdrew his application as he was unable to attend.
- 5. There is currently a balance of \$5,500 available in the 2011/12 Youth Achievement Scheme Fund.

### **BACKGROUND**

- 14. Cameron attends Shirley Boys' High School where he was recently named Sportsman of the Year. He trains nine times a week with the AquaGym swim club and the Canterbury Development Squad. He has a long list of swimming achievements to show for all this hard work. In 2011 he placed first in 50 metres, 100 metres and 200 metres Backstroke at the Short Course National Champs. He also broke two Canterbury Records for Backstroke in the Open Age group at the South Island Champs in September.
- 15. Cameron is seeking funding this year to assist with ongoing costs for competing away from Christchurch, especially since there are no 50 metre pools due to the Earthquake. Every year he typically travels to at least three competitions for events such as the South Island and National Age group competitions as well as the New Zealand Open in Auckland.
- 16. Cameron is a keen sports person and is interested in waterskiing, wakeboarding and rugby. He has been swimming since he was three years old and would love to represent New Zealand at the Commonwealth Games and Olympics. He has also set several goals for 2012 including to: win all Backstroke events for South Island Champs, place in the top 10 finals for New Zealand Opens and break the long standing Canterbury Record for Boys 17 years 200 metres Backstroke.
