#### PURPOSE OF REPORT

1. The purpose of this report is to seek retrospective approval for Board members Paula Smith and Jeremy Agar to attend the Christchurch City Residents Group Forum held at the Canterbury Netball Centre on Saturday 21 April 2012.

- The Christchurch City Residents Group Forum was designed to allow networking for Residents Group members and Community Board members to share ideas to help move forward in the post-earthquake environment.
