She has performed at numerous community events including Culture Galore and the Body Festival and teaches Zumba fitness and dance classes.
- 6. The Australian Salsa Solo Championships will feature top dancers from Australia and around the world and will be held over three days. In addition to the competition, dancers will have the opportunity to take part in Master Class workshops run by world renown dance teachers.
