**1. RICCARTON/WIGRAM TRANSPORT AND ROADING COMMITTEE REPORT OF 1 APRIL 2005**

The Board **received** the report of the Transport and Roading Committee meeting of Friday 1 April 2005.

One member sought to have the proposed “Kennedys Bush Road/Glovers Road/School Road” work advanced within the Capital Works Programme, based on the need to address current safety and traffic concerns in this area.

Members were supportive of the request, but did not support a recommendation by the Principal Adviser to request a report on the implications of bringing this work forward.

A further motion “that the Transport and Roading Committee give further consideration to the current list of planned Neighbourhood Improvement Works within the Riccarton-Wigram community” was considered.

The motion was declared **lost**, on division no. 2 by three votes to four, the voting being as follows:

**For (3):** Helen Broughton, Lesley Keast and Mike Mora.

**Against (4):** Neville Bennett, Peter Laloli, Bob Shearing and Tony Sutcliffe.

The Board **decided** that the Council should proceed with urgency to commence the work on the Kennedys Bush Road/Glovers Road/School Road work.

**4. PROPOSED NEW ROAD NAMES AND RIGHT OF WAY NAMES**

The Board was in receipt of a request from the Subdivisions Officer to approve new road and right of way names at four new residential developments.

One of the names proposed in the Westmorland subdivision was "Hadleigh Lane".

Some members considered that approval for the use of this name should be refused, to allow the use of the similar sounding name "Hadlee" in a future subdivision, to recognise the well known cricketing family.

It was therefore moved "That the Board decline approval for the name "Hadleigh Lane" and that consideration be given to utilising the name "Hadlee" for the naming of a street in a future subdivision".

The motion was declared **lost**, on division no. 1 by three votes to four, the voting being as follows:

**For (3):** Neville Bennett, Helen Boughton and Mike Mora.

**Against (4):** Lesley Keast, Peter Laloli, Bob Shearing and Tony Sutcliffe.

The Board **resolved** to approve the following names:

1. "Stowe Lane" for a right of way to service eight new residential allotments off Kennedys Bush Road.
2. "Hadleigh Lane", "Rushden Rise" and "Holbrook Way", being two new roads and one right of way to service 99 new residential allotments in a subdivision off Pentonville Close, Westmorland.
3. "James Hight Drive", "Cridland Place", "Dunsford Close", "Parklea Avenue" and "Hyde Place", being new roads in the recent stages of development (83 residential allotments) in the Halswell on the Park residential subdivision.
4. "Globe Bay Drive", "Iraklis Close", "Micron Close" and "Blossom Lady Lane", being three new culs-de-sac and one new right of way to service 83 new residential allotments in a subdivision off Jones Road, Templeton.

**5. HEALTHY COOKING PROGRAMME: BOARD FUNDING REQUEST**

The Board was in receipt of a report from Gina Stewart (North Hornby Community Recreation Coordinator) seeking funding for the continuation of the Healthy Lifestyles Programme and fitness classes as part of local Hornby OSCAR and after school programmes.

The Board was supportive of the request, and **resolved** to make a grant of \$5,000, to be funded from its 2004/05 Youth Initiatives Project Fund.
