The Board noted that the Council's Greenspace staff were following up on the issues raised by Mr Smith, and would advise the Board of the outcome.

2. DEPUTATIONS BY APPOINTMENT

2.1 **NEW ZEALAND POLICE**

Trevor Pullen, Senior Sergeant, New Zealand Police updated the Board on crime statistics in the Riccarton/Wigram ward. For the calendar year ending 31 December 2005, the Riccarton/Wigram ward saw a 5.8% reduction in overall reported crime. For the statistical year ending 30 June 2006, the Police were 7% over their forecast. An increase in both burglary and motor vehicle crime has been recorded. Both these areas are seen as Police priority areas.

Inspector John Doyle, Area Commander Southern Christchurch, New Zealand Police presented a proposal to amend the 2001 Christchurch City Traffic and Parking Bylaw as a means to address the boy racing activities in the Hasketts Road/Barters Road area. Boy racers currently cause major disorder and disruption to the local residents.

The Board received the information and **decided** to request a deputation to the Council in support of the Police proposal.

9. CONFIRMATION OF THE PREVIOUS MEETING, 24 MAY 2006

It was **resolved** that the report of the Board meeting of 24 May 2006 be confirmed as a true and accurate record of that meeting.

10. BROKEN RUN - "GIVE WAY" FORMALISATION

The Board considered a report requesting the Board to reconsider its decision of 14 March 2006 to install a "stop" sign against Broken Run at its intersection with Wigram Road, and to formalise a "give way" sign as recommended by Transport & City Streets Unit staff. The Board resolution to install a "stop" sign had not been consistent with the Land Transport New Zealand Road User rules and the Manual of Traffic Signs and Markings.

The Board **resolved** to not accept the staff recommendation to revoke its resolution of 14 March 2006 to install a "stop" sign against Broken Run at its intersection with Wigram Road, due to the following reasons:

- (a) Visibility constraints from the left side at the intersection.
- (b) The possible high speed of vehicles along that stretch of Wigram Road is a potential risk.
- (c) The intersection should be treated in a similar manner as the intersections at Lancewood Drive/Dunbars Road and Ensign Street/Dunbars Road.

(Note: Peter Laloli recorded his vote against the resolution).

11. YOUTH DEVELOPMENT SCHEME - APPLICATION FOR FUNDING

The Board considered a report relating to an application for \$500 from Jessica Graham from its 2005/06 Youth Development Scheme.

The Board **resolved** to allocate \$500 from its 2005/06 Youth Development Scheme to assist with costs associated with the applicant, Jessica Graham, travelling to the Ke Ola Hou Hui event in Hawauu, June 2006.

13. RICCARTON/WIGRAM COMMUNITY SERVICES COMMITTEE REPORT OF THE MEETING OF 24 MAY 2006

1. DENTON PARK – PEGASUS CYCLE CLUB'S APPLICATION TO ASSIGN THEIR LEASE TO THE HORNBY SOCCER CLUB, AND TO GRANT PERMISSION FOR THE HORNBY SOCCER CLUB TO SUBLEASE PART OF THE GROUND FLOOR BACK TO THE PEGASUS CYCLE CLUB

The Board resolved:

- (a) To approve the assignment of lease, dated 14 August 1991, over 227 square metres of Denton Park from the Pegasus Cycling Club to the Hornby Soccer Club.
- (b) That the Hornby Soccer Club be granted the right to sublease 102 square metres of the ground floor of the premises to the Pegasus Cycling Club for storage purposes.
- (c) To request a staff report on options for the long term use of the area for either cycleways or a velodrome facility.

2. APPLICATIONS FOR FUNDING - YOUTH DEVELOPMENT SCHEME

The Board resolved:

- (a) To allocate \$500 from its 2005/06 Youth Development Scheme, to the Riccarton High School Drama Department, for travel and accommodation costs associated with eight students travelling to Wellington for the Sheila Winn National Drama Competition.
- (b) To allocate \$200 from its 2005/06 Youth Development Scheme, to Johnny Brock, for costs related with the applicant travelling to Wellington to compete with his band in the National Christian Talent Competition finals on 3 June 2006. (The Board resolved to allocate \$340 to this applicant, however, the applicant now only requires \$200).
- (c) To allocate \$150 to Gabrielle Brodie and \$150 to Laura Ashton from its 2005/06 Youth Development Scheme to assist with costs associated with each applicant participating in the Friendship Games in Sydney, July 2006.
- (d) To allocate \$150 to Robbie Smith and \$150 to Aiden Ponsonby from its 2005/06 Youth Development Scheme to assist with costs associated with the applicants participating in their respective tournaments, in Sydney, July 2006.
