PART C - REPORT ON DELEGATED DECISIONS TAKEN BY THE BOARD

13. CONFIRMATION OF MEETING REPORT – 16 AUGUST 2006

It was **resolved** that the report of the Board's meeting of 16 August 2006 be confirmed as a true and accurate record of that meeting.

14. DARROCH RESERVE - FENCING

The Board's approval was sought to install post and cable fencing with associated plantings and open access points on the front and rear boundaries of Darroch Reserve, following community consultation.

The Board **resolved** to approve the installation of post and cable fencing with associated plantings and open access points on the front and rear boundaries of Darroch Reserve.

15. BROOKLANDS DOMAIN – TENNIS COURT

The Board's approval was sought to the location and construction of a tennis court within Brooklands Domain.

The Board **resolved** to approve Location D as detailed in the attachment to the agenda as the tennis court location, in order to proceed to detailed design and construction of the Brooklands Domain tennis court.

16. QUEENSPARK BUS PRIORITY PROJECT - HILLS ROAD

The Board's approval was sought to proceed to consultation, design and construction of the trial Bus Boarder as shown in the concept plans in attachment 1 to the agenda.

The Board **resolved**:

1. To approve the Hills Road Bus Boarder trial, as illustrated in attachment 1 of the agenda, to proceed to consultation, design, and construction.
2. To request the trial be undertaken over a period of three months.
3. To seek the support of the Police to monitor traffic behaviour.
4. That staff consider a reward system (free bus passes) for motorists displaying good behaviour.

17. NOTICES OF MOTION

Pursuant to Standing Orders 2.16.1, the following notices of motion were received:

- (i) *Sawyers Arms Road/Lacebark Lane*

"That Transport Unit staff investigate the parking of vehicles on the corner of Lacebark Lane/Sawyers Arms Road and that marking of bus stops be carried out to prevent vehicles from parking on the bus stops. Consultation with the resident on the corner of Lacebark Lane to be undertaken in regard to the possible shifting of the bus stop to this site."

The Board **resolved**:

- (a) That Transport & Greenspace Unit staff investigate the parking of vehicles on the corner of Lacebark Lane/Sawyers Arms Road and that marking of bus stops be carried out to prevent vehicles from parking on the bus stops.
- (b) That consultation with the resident on the corner of Lacebark Lane be undertaken in regard to the possible shifting of the bus stop to this site.

(ii) *104-106 Sawyers Arms Road*

"That the Board request Transport Unit staff to install a loading zone outside the businesses located at 104-106 Sawyers Arms Road to allow large trucks to park while waiting to access Christchurch Steel (the Manager of the business supports the Board's actions)."

The Board **resolved** that Transport & Greenspace Unit staff install a loading zone outside the businesses located at 104-106 Sawyers Arms Road to allow large trucks to park while waiting to access Christchurch Steel.

(iii) *113-117 Sawyers Arms Road*

"That the Board request Transport Unit staff to investigate safety issues and carry out appropriate works to remedy residents' concerns relating to such matters being experienced as a result of the increase in parking from the industrial buildings on Sawyers Arms Road."

(Moved by Norm Withers, seconded by Yvonne Palmer.)

The Board **resolved** that Transport & Greenspace Unit staff investigate safety issues in relation to 113-117 Sawyers Arms Road that have arisen due to an increase in parking from the industrial buildings on Sawyers Arms Road and carry out appropriate remedial works to allay residents' concerns.

- (iv) *"On the basis that a number of school principals have indicated an interest in participating in Junior Neighbourhood Support, the Board request a report from staff regarding the provision of further funding to support this initiative in the Shirley/Papanui community."*

(Moved by Yvonne Palmer, seconded by Myra Barry.)

The Board **resolved** to request a report from staff regarding the provision of further funding to support this initiative in the Shirley/Papanui community (on the basis that a number of school principals have indicated an interest in participating in Junior Neighbourhood Support).

- (v) *"That the Board request urgent consideration be given to Husseys Road being upgraded with footpaths in order to meet safety standards. This road has gone from being a rural cul-de-sac to an open road carrying at least 500% more traffic resulting from the Northwood and Styx Mill County Club developments."*

(Moved by Yvonne Palmer, seconded by Norm Withers.)

The Board **resolved** to seek speaking rights at a Council meeting to request urgent consideration be given to Husseys Road being upgraded with footpaths in order to meet safety standards.

The meeting concluded at 7.05 pm.
