1. HILLS ROAD - BUS BOARDER TRIAL

It was noted that the staff recommendations relating to the Bus Boarder Trial were fully supported by the cycling organisation SPOKES.

Councillor Shearing moved by way of amendment:

- "(a) That the Council grant approval for the Hills Road Bus Boarders three months trial proposal to proceed to design and construction, as shown in attachment 1.*
- (b) That, prior to design and construction of the bus boarders proposed to be installed along Hills Road the views of the Automobile Association and the owners and occupants of the immediately adjoining properties be sought as part of the consultation process and, should they express any concerns, they be offered an opportunity to discuss these concerns with the Council.*
- (c) That approval be granted for new cycle lanes to be installed adjacent to the kerb in the following locations:*
 - (i) On the east side of Hills Road, commencing at a point 52 metres north from its intersection with Dudley Street and extending in a northerly direction for a distance of 130 metres.*
 - (ii) On the west side of Hills Road, commencing at a point 103 metres south from its intersection with Edgeware Road and extending in a southerly direction for a distance of 25 metres.*
 - (iii) On the west side of Hills Road, commencing at a point 67 metres south from its intersection with Edgeware Road and extending in a southerly direction for a distance of 23 metres.*

- (iv) *On the west side of Hills Road, commencing at a point 38 metres south from its intersection with Edgeware Road and extending in a southerly direction for a distance of 19 metres.*
- (v) *On the west side of Hills Road, commencing at a point 14 metres north from its intersection with Edward Avenue and extending in a northerly direction for a distance of 18 metres.*
- (d) *That the stopping of vehicles be prohibited at any time on the east side of Hills Road commencing at its intersection with Dudley Street and extending for 6 metres in a northerly direction.*
- (e) *That the parking of vehicles be restricted to a maximum period of 30 minutes on the west side of Hills Road commencing at a point 96 metres south from its intersection with Edgeware Road and extending in a southerly direction for a distance of 7 metres.*
- (f) *That the existing bus stop currently located on the west side of Hills Road at a point commencing 53 metres south of the intersection with Edgeware Road and extending 17 metres in a southerly direction be removed, and reinstated on the west side of Hills Road commencing 57 metres south of the intersection with Edgeware Road and extending 10 metres in a southerly direction.*
- (g) *That the existing bus stop currently located on the west side of Hills Road at a point commencing 98 metres north of the intersection with Edward Avenue and extending 15 metres in a northerly direction be removed, and reinstated on the west side of Hills Road commencing at a point 4 metres north from its intersection with Edward Avenue and extending in a northerly direction for a distance of 10 metres.*
- (h) *That all existing no stopping at any time restrictions in the foregoing areas be revoked."*

The amendment was seconded by Councillor Buck and when put to the meeting was declared **carried** as the substantive motion.

(Note: Councillor Sheriff recorded her vote against the adoption of the amendment.)
