PART B – REPORTS FOR INFORMATION

1. ROAD LEGALISATION – BROOKWATER AVENUE

The Board **decided** that the report on this matter lie on the table until the next Board meeting on 18 July 2007 so that further information could be obtained from staff.

2. DEPUTATIONS BY APPOINTMENT

2.1 Justine Forde, Child, Youth and Family, Christchurch

Justine Forde, Community Liaison Social Worker for Child, Youth and Family in Christchurch, presented information to the Board about National Children's Day and invited the Board to consider moving its own Children's Day Event from October 2007 to March 2008 to coincide with the timing of the national event.

Members responded to Ms Forde's proposal indicating that as arrangements for its own event in October were already well advanced, there would be a reluctance to consider making a date change as requested.

In thanking Ms Forde for her attendance the Chairperson indicated that the matter would, however, be further discussed at a forthcoming Board seminar.

2.2 Mr Francis Pipe, 3 Mahars Road

Mr Pipe addressed the Board regarding parking issues and general road safety concerns regarding the junction and bends in the immediate vicinity of the Mahars Road/Westminster Street intersection and asked the Board for its assistance.

The Board **resolved** to request a report from staff on the matters raised including the installation of no stopping lines on both sides of Westminster Street at its intersection with Mahars Road.

PART C – REPORT ON DELEGATED DECISIONS TAKEN BY THE BOARD

9. CONFIRMATION OF MEETING REPORT – 20 JUNE 2007

It was **resolved** that the report of the Board's ordinary meeting of 20 June 2007 be confirmed as a true and accurate record of that meeting.

10. NAMING PROCEDURE FOR THE STYX CATCHMENT

The Board considered a report from the Parks and Waterways Planner (Christine Heremaia) seeking approval in principle, subject to further consultation, for a procedure for the naming of new reserves and important natural and cultural features alongside waterways and wetlands within the Styx catchment.

The Board **resolved** to support the following 'Naming Procedure' in principle, subject to further public consultation, community and Council input:

'The following naming procedure applies only to the Styx catchment and is in addition to the Christchurch Code Of Practice for Naming Reserves and Facilities

- (i) *The Maori names derived from oral tradition, which are regarded as taonga (treasures) of the people and have traditionally been passed on from generation to generation. These are often associated with historic events and persons;*
- (ii) *Maori names adopted and adapted by Europeans, sometimes misplaced or misspelt or corrupted in some way;*
- (iii) *Maori versions or transliterations of European place names:*
Eg *Atens* = *Athens*
 Ranana = *London*
 Hiruharama = *Jerusalem*
- (iv) *Those names brought by European explorers and settlers and their descendents;*
- (v) *Names given since European settlement to commemorate people, events or other associations with the place;*
- (vi) *A combination of both Maori and European as dual names, to represent both histories of New Zealand.*

11. MURCHISON PARK DEVELOPMENT PLAN

The Board considered a report by the Consultation Leader Greenspace (Mary Hay) seeking approval to:

- (a) proceed to detailed design and construction/implementation of the Murchison Park Development Plan and playground upgrade; and
- (b) proceed to detailed design and construction of the Lowry Avenue safety improvements; and
- (c) supplement new no-stopping restrictions associated with the Lowry Avenue safety improvements.

The Board **resolved:**

- (a) That approval be granted for the Murchison Park Development Plan and playground upgrade to proceed to detailed design and construction/implementation, in accordance with the plans submitted to the Board dated June 2007;
- (b) That approval be granted for the Lowry Avenue safety improvements to proceed to detailed design and construction, in accordance with plans submitted to the Board dated June 2007.
- (c) To approve the following new traffic restrictions.

New No Stopping - Lowry Avenue

That the stopping of vehicles be prohibited at any time in the following locations:

- (i) On the north west side of Lowry Avenue, commencing at a point 34 metres from the south west kerb line of Goodall Street and extending south west for a distance of 10 metres.

- (ii) On the south west side of Lowry Avenue, commencing at a point 21 metres from the south west kerb line of Goodall Street and extending south west for a distance of 40 metres.
- (iii) On the south west side of Lowry Avenue, commencing at a point 6 metres from the south west kerb line of Goodall Street and extending north west for a distance of 20 metres.
- (v) On the south west side of Lowry Avenue, commencing at a point 55 metres from the north east kerb line of Goodall Street and extending north east for a distance of 14 metres.
- (vi) On the north east side of Lowry Avenue, commencing at a point 56 metres from the north east kerb line of Goodall Street and extending north east for a distance of 13 metres.

12. EDGEWARE/COLOMBO AND EDGEWARE VILLAGE – TRAFFIC MANAGEMENT

The Board considered the contents of a memorandum from the Traffic Engineer - Community (Basil Pettigrew) regarding the Edgware Road pedestrian zebra crossing.

The Board **resolved** to refer the matter to a forthcoming Board seminar for more in depth consideration.

13. YOUTH DEVELOPMENT FUND COMMITTEE - MEETING REPORT

The Board **received** the report of its Youth Development Fund Committee meeting of 20 June 2007 held to decide on the allocation of funding to two local young people
