14. CORRECTION OF MINOR ERRORS IN THE CITY PLAN AND IN THE PROPOSED BANKS PENINSULA DISTRICT PLAN

PURPOSE OF REPORT

1. The purpose of this report is to recommend that the Council correct minor errors in the City Plan and in the Banks Peninsula Proposed District Plan.

EXECUTIVE SUMMARY

- 2. A number of minor errors have been identified in the City Plan and in the proposed Banks Peninsula District Plan. Errors in the City Plan include an incorrect listing for a protected building and the deletion of a rule that is no longer relevant as a consequence of a Council decision.
- 3. Many of the amendments required for the Proposed Banks Peninsula District Plan are to correct mapping errors and inappropriate zonings, for example privately owned land zoned as Recreation or Conservation Reserve. A legal opinion by Buddle Findlay in relation to similar zoning issues raised by a landowner in the Wainui area, and considered by the Council at its meeting on 20 September 2007, supports the use of Clause 16(2) to correct inappropriate zoning where the current zoning is clearly a mistake and there is no material difference in the uses permitted.

FINANCIAL IMPLICATIONS

4. There are no financial implications in correcting the minor errors identified.

6. Correcting minor errors in District Plans is provided for in the Resource Management Act 1991. Clause 16(2) of the First Schedule to the Act provides that a local authority may make an amendment, without further formality, to a proposed plan to alter any information, where such an alteration is of minor effect, or may correct minor errors. Clause 20 A of the First Schedule to the Act provides that a local authority may amend, without further formality, an operative plan to correct minor errors.
