**A meeting of the Burwood/Pegasus Community Board  
was held on Wednesday 20 June 2007 at 5.00 pm**

**PART B - REPORTS FOR INFORMATION**

**1. CORRESPONDENCE**

**1.1 GOLF LINKS ROAD AND MCCORKINDALE PLACE TRAFFIC ISSUES**

Letters were received from Nadine and Greg Campbell, Gladys Cox and Kenneth Ratcliffe, residents of McCorkindale Place, outlining their concerns about traffic issues in the vicinity of McCorkindale Place and Golf Links Road.

**1.2 SHIRLEY ROAD/MARSHLAND ROAD/NORTH PARADE/NEW BRIGHTON ROAD INTERSECTION**

A letter was received from Christine and Philip Haythornthwaite outlining their concern regarding traffic turning right from Shirley Road into North Parade.

**1.3 METRO SERVICE ROUTE 60 - ROUTE ALTERATION**

A letter was received from Trevor Bartle outlining his request to change the route of bus 60 to loop around behind Burwood Hospital and through Tumara Park.

The Board **decided**:

- (a) That the items of correspondence be received.
- (b) That items 1.1 and 1.2 be referred to the Transport and Greenspace Unit for consideration with a report back to the Board.
- (c) That item 1.3 be referred to Environment Canterbury for consideration.

**2. DEPUTATION BY APPOINTMENT**

**WAITIKIRI DRIVE STREET LIGHTING**

**Ron McPhail** from the Waitikiri Golf Club was in attendance and tabled supporting information seeking additional street lighting to help alleviate the problems with boy racers, rubbish and graffiti at the end of Waitikiri Drive.

The Board **decided** to seek a report from the Transport and Greenspace Unit regarding when the upgrading of lighting in Waitikiri Drive (northern end) could be programmed for health and safety reasons.

Time is allocated at Board meetings for Residents' Association/Community Group representatives to address the Board on local matters. Each group is being invited to do this in rotation.

**NORTH NEW BRIGHTON RESIDENTS' ASSOCIATION**

**Dave East** was in attendance and provided the Board with an update on the Association's activities and issues.

**4. COMMUNITY BOARD PRINCIPAL ADVISER'S UPDATE**

The Board **received** items of information under the Community Board Principal Adviser's Update and **decided** to write a letter to the Transport and Greenspace Unit to note its appreciation in the improvement in the number of requests for service in relation to streets maintenance, lighting, footpaths, street signs and grass maintenance.

**5. BOARD MEMBERS' INFORMATION EXCHANGE**

**FIRE EVACUATION DRILL - THE PALMS**

It was observed at a recent fire drill at The Palms that there were major traffic issues in the car park, and that vehicles were still able to enter/exit the car park during the drill. The opinion was expressed that this could pose a potential problem for fire engines trying to get to the main entrances of the mall.

The Board **decided** that a letter be sent to the New Zealand Fire Service advising it of this potential problem, and suggesting that suitable remedial measures be implemented.

**6. CONFIRMATION OF REPORT**

The Board **resolved** that the report of the ordinary meeting held on Wednesday 6 June 2007 be confirmed.

**7. CLAREVALE STREET - PROPOSED PARKING RESTRICTIONS**

The Traffic Engineer (Community) sought the Board's approval for the installation of a 5 minute, "8.00-9.00am and 2.30-3.30pm, school days" parking restriction and "no stopping" lines, on the north-western side of the cul-de-sac head in Clarevale Street, at the rear entrance to the Windsor School, Burwood.

The Board **resolved**:

- (a) That the parking of vehicles be restricted to a maximum period of 5 minutes, between 8am and 9am and 2.30pm and 3.30pm on school days on the western side of the cul-de-sac head in Clarevale Street commencing at a point 238 metres from its intersection with Burwood Road and extending in a northerly direction for a distance of 32 metres.
- (b) That the stopping of vehicles be prohibited at any time on the northern side of the cul-de-sac head in Clarevale Street commencing at a point 270 metres from its intersection with Burwood Road and extending in a north-easterly direction for a distance of 25 metres.

Following consideration of a report by the Parks and Waterways Area Advocate, the Board **resolved** to grant approval for the Avondale Park Storeroom proposal to proceed to detailed design and construction.

**9. YOUTH DEVELOPMENT FUND - WILLIAM SILCOCK**

The Community Recreation Adviser sought the Board's approval of an application for funding from its 2006/07 Youth Development Funding Scheme.

The Board **resolved** to allocate \$500 from its 2006/07 Youth Development Funding Scheme to William Silcock for his attendance at the Partille Cup and the Dronninglund Cup Tournaments for the New Zealand Handball Under 21 Men's Team from 2-22 July 2007.

**10. YOUTH DEVELOPMENT FUND - LUKE SEARLE AND TEGAN MADDEN**

The Community Recreation Adviser sought the Board's approval of applications for funding from its 2006/07 Youth Development Funding Scheme.

The Board **resolved** to allocate \$500 each from its 2006/07 Youth Development Funding Scheme to Luke Searle and Tegan Madden for their attendance at the New Zealand Boxing Championships in Taupo from 25-28 May 2007.

The meeting concluded at 6.10 pm.
