**HAGLEY/FERRYMEAD COMMUNITY BOARD
26 APRIL 2007**

**A meeting of the Hagley/Ferrymead Community Board
was held on Wednesday 26 April 2007 at 3.00pm**

PRESENT: Bob Todd (Chairperson), David Cox, Anna Crighton, Yani Johanson and Brenda Lowe-Johnson.

APOLOGIES: Apologies for absence were received and accepted from John Freeman and Brendan Smith.

An apology for lateness was received and accepted from Brenda Lowe-Johnson who arrived at 3.07pm and was absent for part of clause 2.

An apology for early departure was received from Anna Crighton who retired at 4.30pm and was absent for clause 4.3.

The Board reports that:

PART B - REPORTS FOR INFORMATION

1. CORRESPONDENCE

2. COMMUNITY BOARD PRINCIPAL ADVISER'S UPDATE

The Board **received** a report on current topics of interest.

The Board also **received** a memorandum relating to an existing retaining wall by 36 and 38 Kinsey Terrace. The memorandum was in response to a resolution passed by the Board on 20 December 2006, and subsequent questions raised by Anna Crighton at the Board meeting on 14 March 2007. In response to other questions raised at that meeting, the plaques have been actioned and the other requests noted.

The memorandum state inter alia:

"Based on the findings of this second opinion (re: structural integrity of wall)" a new retaining wall has been included in the contract documents for Kinsey Terrace Street Renewal. In zone A the existing wall will be replaced with a new structural wall. Depending on the tender process received, the existing wall in Zones B and C will either be replaced in the contract with new structural walls, or not replaced but regularly monitored and appropriate action taken as and when required."

3. QUESTIONS FROM MEMBERS

Yani Johanson asked the following questions under Standing Order 4.1:

1. Where is the report on improving cyclist safety in the Sumner to Mount Pleasant area?

The Community Board Principal Adviser advised that in response to the question, some short term measures had been undertaken but information has not been provided back to the Board. This would be arranged.

2. What is happening with the horse grazing resolutions?

The Community Board Principal Adviser advised that following the Council resolution of 15 February 2007, a report to the Council was expected to be finalised by the end of May for a June report to the Council.

4. DEPUTATIONS BY APPOINTMENT

4.1 Englefield Residents' Association Inc.

Maxine Webb, Irinka Britnell, Robyn Kilty and the Reverend Hugh Bowron spoke on several items of mutual interest. Barry Cook (Senior Liaison Officer – Transport and Greenspace Unit) also contributed to the discussions covering:

1. Neighbourhood Improvement Plans including submissions to the Council on specific projects and the City Plan.
2. Protection for the Englefield Historic Area.
3. Out of Court Settlement 2001 – Englefield Residents' Association and Christchurch City Council City Streets Unit.

In **receiving** this information the Board noted that staff would follow up the concerns expressed, and that copies of the documentation provided by Englefield representatives from the Association would be distributed to Board members.

A walk about with the Board of the Englefield area will be arranged as part of Heritage Week.

4.2 New Zealand Police

Inspector Garry Knowles plus his community constables attended the meeting to brief the Board on recent policing in the Hagley/Ferrymead Community Board area, in particular a Police initiative, "Operation Hammer".

Inspector Knowles provided a briefing paper which outlined the background, purpose and phases for this high profile operation, and together with his team responded to questions from Board members.

The Board **received** the information.

4.3 Youth Consultation – Central City Programme

Mauice Roers (Senior Planner, Central City Policy and Planning Team) and Matthew Pratt (Metropolitan Community Adviser – Youth) attended the meeting and updated the members on consultation carried out with youth in respect of the central city programme (e.g. City Mall and Bus Exchange).

They outlined the considerable amount of effort made to consult and responded to questions from Board members.

The Board **received** the information.

6. SETTLERS CRESCENT PROPOSED NO STOPPING RESTRICTION

The Board considered a report seeking its approval to the installation of two sections of broken yellow "no stopping" lines on two corners in Settlers Crescent, Ferrymead.

The Board **resolved**:

- (a) That the stopping of vehicles be prohibited at all times on the east and north sides of Settlers Crescent commencing at a point 104 metres south of the Ferry Road (west) intersection and extending in a southerly, then easterly direction for a distance of 22.5 metres.
- (b) That the stopping of vehicles be prohibited at all times on the west and north side of Settlers Crescent commencing at a point 98 metres south of the Ferry Road (east) intersection and extending in a southerly, then westerly direction for a distance of 16 metres.

7. PRESENTATION

The Board presented a Certificate of Appreciation and a bouquet of flowers to Ailsa Burnip (moving from Woolston) to recognise her enthusiasm, patience and 99.9% attendance at Board meetings since 1989. Ailsa was also recognised for her contributions to the Woolston community.

The meeting concluded at 4.50pm.
