4. DEPUTATIONS BY APPOINTMENT

4.1 INSTALLATION OF POSTER BOLLARDS ON ROADS

Jamie Holloway, on behalf of Phantom Bill Stickers Limited, addressed the Board on proposed locations for the installation of poster bollards on roads in the Riccarton/Wigram area.

The Board received the information and its recommendations on this matter are recorded under clause 6 of this report.

4.2 YALDHURST RURAL RESIDENTS' ASSOCIATION

Bob Cross, Chairman of the Yaldhurst Rural Residents' Association, addressed the Board to seek financial assistance for costs associated with appealing a recent Environment Court decision on the resource consent application for the Miners Road Quarry in Yaldhurst.

The Board received the information and **decided** to request a report from staff on the Association's request for assistance, to be submitted to a forthcoming Community Board meeting in the New Year.

(Note: Bob Shearing abstained from the discussion and voting on this matter.)

Representatives from the Wigram Residents' Association were unable to attend the meeting.

6. INSTALLATION OF POSTER BOLLARDS ON ROADS

The Board considered a report seeking its support for the installation of poster bollards proposed by Phantom Bill Stickers Limited in the following six locations:

- (a) CH0604 – Nelson Street (between Picton Ave and Clarence St behind Blood Bank Services Carpark).
- (b) CH0514.1 – Rotherham Street outside Westfield south east end.
- (c) CH0513.1 – Rotherham Street outside Westfield south west end.
- (d) CH0515.1 – Rotherham Street outside ANZ Bank.
- (e) Chalmers Street by cycleway to Denton Park.
- (f) CH0603 – Picton Avenue/Riccarton Road outside KFC.

The Board did not support the installation of all six bollards, on the basis that three on Rotherham Street was too many. The Board decisions on each proposed location were as follows:

- (a) CH0604 – Nelson Street (between Picton Avenue and Clarence Street behind Blood Bank Services Carpark).

A resolution supporting the installation of a poster bollard in this location was **adopted** on division no 1 by four votes to three, the voting being as follows:

For(4): Neville Bennett, Helen Broughton, Lesley Keast, Tony Sutcliffe.
Against(3): Mike Mora, Peter Laloli, Bob Shearing.

- (b) CH0514.1 – Rotherham Street outside Westfield south east end.

A motion that the installation of a poster bollard in this location be supported was **lost** on division no 2 by four votes to three, the voting being as follows:

For(3): Helen Broughton, Lesley Keast, Tony Sutcliffe.
Against(4): Neville Bennett, Mike Mora, Peter Laloli, Bob Shearing.

- (c) CH0513.1 – Rotherham Street outside Westfield south west end.

A motion that the installation of a poster bollard in this location be supported was **lost** on division no 3 by four votes to three, the voting being as follows:

For(3): Helen Broughton, Lesley Keast, Tony Sutcliffe.
Against(4): Neville Bennett, Mike Mora, Peter Laloli, Bob Shearing.

- (d) CH0515.1 – Rotherham Street outside ANZ Bank.

A resolution supporting the installation of a poster bollard in this location was **adopted** on division no 4 by four votes to three, the voting being as follows:

For(4): Neville Bennett, Helen Broughton, Lesley Keast, Tony Sutcliffe.
Against(3): Mike Mora, Peter Laloli, Bob Shearing.

- (e) Chalmers Street by cycleway to Denton Park.

A resolution supporting the installation of a poster bollard in this location was **adopted** on division no 5 by four votes to three, the voting being as follows:

For(4): Neville Bennett, Helen Broughton, Lesley Keast, Tony Sutcliffe.
Against(3): Mike Mora, Peter Laloli, Bob Shearing.

- (f) CH0603 – Picton Avenue/Riccarton Road outside KFC.

A motion that the installation of a poster bollard in this location be supported was **lost** on division no 6 by four votes to three, the voting being as follows:

For(3): Helen Broughton, Lesley Keast, Tony Sutcliffe.
Against(4): Neville Bennett, Mike Mora, Peter Laloli, Bob Shearing.

A report to the Council is being prepared by staff, seeking approval of poster bollards proposed by Phantom Bill Stickers across the city, that will include the views of all Community Boards consulted on this issue.

- (b) That Council staff be requested to arrange a Board seminar to update the Board on developments relating to Canterbury Park.
- (c) That Richard Lloyd be invited to provide an update to the Board on developments relating to the Owaka Pit.

13.2 ROSELLA RESERVE WALKWAY GATE

That Council staff be requested to investigate the placement of a see-through gate at the Carmen Road end of the walkway in Rosella Reserve, to ensure greater visibility for pedestrians.

- 14.2 To request an update from staff on the implications under the draft Community Development Strategy of the ongoing availability of the Council's Metropolitan and Social Initiatives funding to cover existing operational funding for projects in the Riccarton/Wigram area.
- 14.3 To include, in its submission on the draft Community Development Strategy, the Board's wish to secure ongoing operational funding for local projects.
- 14.4 To allocate \$300 to Ricky Cook from its 2006/07 Youth Development Fund for costs associated with the applicant attending the National Men's Open Bowls Championships being held in Dunedin from 28 December to 9 January 2007.
- 14.5 To allocate \$300 to Andrew Kelly from its 2006/07 Youth Development Fund for costs associated with the applicant attending the National Men's Open Bowls Championships being held in Dunedin from 28 December to 9 January 2007.
- 14.6 To allocate \$3,757 from its 2006/07 Discretionary Fund to the Canterbury/Northwest Salvation Army for the provision of a Budget Adviser for the period 1 January to 30 June 2007.
- 14.7 To allocate \$7,500 from its 2006/07 Discretionary Fund for the purchase of sound recording equipment for the History of Hornby Project.

15.1 DEPUTATION BY APPOINTMENT - WESTMORLAND RESIDENTS' ASSOCIATION

The Board **resolved** to:

- (a) Request a report from staff on issues likely to arise from future subdivisions in the Westmorland area, the associated implications in respect of the existing roading infrastructure, and possible solutions to resolve the issues identified.
- (b) Invite the developer of the new subdivision to attend a forthcoming Transport & Roding Committee meeting to provide an update on future developments.
- (c) Seek an update from staff on progress on the repair of the slip lane at the intersection of Cashmere Road and Penruddock Rise.

15.2 DEPUTATION BY APPOINTMENT – RICCARTON PARK RESIDENTS' ASSOCIATION

The Board **resolved** to request information from staff on:

- (a) The zonings for the area around 89 Buchanans Road and the requirements for Living 1 zones.
- (b) The parameters for commercial zones and any examples within the City where solutions have been found for the interface between commercial and living zones.

15.3 CHURCH CORNER – ON STREET PARKING REVIEW

The Board **resolved**:

- (a) That the stopping of vehicles be prohibited at all times in the following locations:
 - (i) On the west side of Angela Street between Yaldhurst Road and Bowen Street.
 - (ii) On the west side of Brake Street commencing 12 metres north of the Yaldhurst Road intersection and extending in a northerly direction for a distance of 12 metres.
 - (iii) On the east side of Brake Street commencing 14 metres north of the Yaldhurst Road intersection and extending in a northerly direction for a distance of 10 metres.
- (b) That parking "ticks" be installed adjacent to vehicle entrances on both sides of Brake Street, Bowen Street, Leslie Street and the east side of Angela Street.

15.4 O'HALLORAN DRIVE – NEIGHBOURHOOD IMPROVEMENT WORK

The Board **resolved** that the staff report on this matter be deferred, pending further investigation from staff on alternative treatment options for this area with a particular emphasis on Sabys Road.

15.5 FOREMANS ROAD – GIVE WAY CONTROL

The Board **resolved** that a "Give Way" control be installed against the cul-de-sac section (western end) of Foremans Road at the T-junction of Foremans Road (east and south approach).
