2. CONFIRMATION OF REPORT

3. BOWHILL ROAD - MOTORCYCLE PARKING

The Board **resolved** not to approve the installation of the "motorcycle only at any time" park.

4. WAITAKI STREET - PROPOSED "NO STOPPING" RESTRICTION

5. ANZAC RESERVE AND AMELIA ROGERS RESERVE DEVELOPMENT PLANS
