A meeting of the Burwood/Pegasus Community Board was held on Wednesday 5 September 2007 at 5.00 pm in the Boardroom, Corner Beresford and Union Streets, New Brighton

- **PRESENT:** Glenda Burt (Chairperson), Carole Evans, Carmen Hammond, Caroline Kellaway, Tina Lomax and Don Rowlands.
- APOLOGIES: An apology for absence was received and accepted from Gail Sheriff.

Apologies for lateness were received and accepted from Caroline Kellaway and Don Rowlands.

Caroline Kellaway arrived at 5.05 pm and was absent for clause 5.

Don Rowlands arrived at 5.06 pm and was absent for clauses 5 and 6.

The Board reports that:

PART A – MATTERS REQUIRING A COUNCIL DECISION

1. HOURS OF FISHING FROM THE NEW BRIGHTON PIER

At its meeting on 21 June 2007 the Council resolved:

- (a) That fishing on the pier be restricted to certain days and times and be reviewed in 12 months time.
- (b) That the Burwood/Pegasus Community Board be delegated power to decide the days and times during which the restrictions set out in (a) are to apply.
- (c) That a person be employed to carry out enforcement.

In relation to (b) above, the Board considered a report from the Regional Parks Team Manager and Coastal Parks Area Head Ranger recommending that the Board, acting under delegated authority, resolve:

- To allow fishing to continue on the New Brighton Pier except for the time between 6am and 6pm on weekends and statutory holidays during the months of daylight saving. (This summer beginning 30 September 2007 and ending on 6 April 2008.)
- (ii) To remove the existing small "no fishing" zone marked at the end of the pier.

Members also discussed the issues of crab fishing, the use of rod numbers per person and the budget requirements for enforcement services beyond the present financial year.

Clause 8 of this report (Part C) records the Board's delegated decisions on the hours of fishing from the pier and related matters.

BOARD RECOMMENDATION

That in relation to the New Brighton Pier, the Council resolve:

- (a) That a year round ban be placed on crab fishing
- (b) That fishing be restricted to one rod per person at all times
- (c) That budget provision be made for enforcement services beyond the 2007/08 year.

(Note: Don Rowlands recorded his vote against the adoption of recommendation (a) above.)

2. COMMUNITY BOARD ADVISER'S UPDATE

The Board **received** an update on forthcoming Board related activities over the coming weeks.

On the matter of the Council's Bylaw Review Subcommittee, feedback was being sought from Boards on the bylaws dealing with public places and signs.

For the assistance of its representative on the Council's Subcommittee (Tina Lomax), the Board indicated a preference for the relevant provisions of the Banks Peninsula bylaw noting similarities with the extensive coastal zone, recreational areas and tourist destinations located in the Burwood/Pegasus Ward.

3. KEEP NEW ZEALAND BEAUTIFUL CONFERENCE

Further to a report from the Community Board Adviser, the Board **decided** not to appoint a delegate to the September conference in Auckland as its representative (Carole Evans), was unable to attend. However, members did request that details of the conference proceedings be circulated when available.

4. BOARD MEMBERS' INFORMATION EXCHANGE

Specific mention was made of the following matters:

- Rothesay Road trees in relation to the recent meeting held with local residents, staff were requested to respond back to the Board on the following matters:
 - lighting on the section of Rothesay Road between Kohi Drive and Queenspark Drive.
 - the feasibility and costs of moving the post and cable fence from the edge of the roadway owing to flooding.
 - possible traffic calming measures on Rothesay Road between Queenspark and Kohi Drives.
- Local liquor licensing renewals no community related issues regarding recent renewal applications.
- Dallington Cottage Annual General Meeting successful recent meeting held.
- Funding Assessment Committee arising from recent meetings of the Committee the matter of
 ongoing support and self sufficiency issues regarding future funding assistance will need to be
 addressed by the Board.
- New Brighton Project/Historical Society the success of the recent Golden Oldies film day was noted.

PART C - DELEGATED DECISIONS TAKEN BY THE BOARD

5. CONFIRMATION OF MEETING REPORT – 15 AUGUST 2007

The Board **resolved** that the report of its ordinary meeting held on 15 August 2007, be confirmed.

6. TRAVIS COUNTRY DRIVE - PROPOSED NO STOPPING RESTRICTIONS

The Board's approval was sought for the installation of no stopping restrictions on both sides of the eastern entrance to Travis Country Drive at its intersection with Travis Road (State Highway 74).

The Board **resolved** that the stopping of vehicles be prohibited at any time:

- (a) On the west side of the eastern entrance to Travis Country Drive commencing at its intersection with Travis Road and extending in a northerly direction for a distance of 47 metres.
- (b) On the east side of the eastern entrance to Travis Country Drive commencing at its intersection with Travis Road and extending in a northerly direction for a distance of 47 metres.

7. SOUTH BRIGHTON MOTOR CAMP – PROPOSED INCREASE IN CAMP CHARGES

The Board's approval was sought to increase charges for tent and caravan sites only at the South Brighton Motor Camp.

The Board **resolved** to approve the submitted schedule of increased charges for the South Brighton Motor Camp, to apply from 1 September 2007.

8. HOURS OF FISHING FROM THE NEW BRIGHTON PIER (CONTINUED)

Further to clause 1 (Part A) of this report, the Board **resolved**:

- (a) That no fishing (including crab fishing) be allowed on the New Brighton Pier between 6am and 6pm on weekends and statutory holidays during the months of daylight saving (this summer beginning 30 September 2007 and ending 6 April 2008) but with a proviso that fishing within the restricted period be permitted for special one-off events by authorisation of the Transport and Greenspace Manager.
- (b) To remove the existing small "no fishing" zone marked at the end of the pier.
- (c) That clauses (a) and (b) be reviewed six months after implementation and that in the interim a monthly enforcement activity update be provided to the Board.

(Note: Don Rowlands recorded his vote against the adoption of resolution (a) above.)

9. APPLICATION TO THE BURWOOD/PEGASUS COMMUNITY BOARD'S YOUTH DEVELOPMENT SCHEME

Further to a report by the Community Recreation Adviser, the Board **resolved** to allocate \$150 to Sarah Smit from its 2007/08 Youth Development Funding Scheme.

10. APPLICATIONS TO THE BURWOOD/PEGASUS COMMUNITY BOARD'S YOUTH DEVELOPMENT SCHEME

Having considered a report from the Community Recreation Adviser, the Board **resolved** that Jessica Wilson and Jenny Bailey each be allocated \$250 from the Board's 2007/08 Youth Development Funding Scheme.
