#### LEGAL CONSIDERATIONS

- 4. A Community Board may include members appointed by the Council. Those members must also be Councillors representing the ward in which the Community Board is situated. The number of Councillors must be fewer than half the total number of Community Board members.
- 5. If the Council wishes to appoint Councillors to be members of the Community Boards it is necessary for the Council to resolve to appoint each of the ward Councillors to each of the following Community Boards:

Fendalton/Waimairi Community Board Burwood/Pegasus Community Board Hagley/Ferrymead Community Board Shirley/Papanui Community Board Riccarton/Wigram Community Board Spreydon/Heathcote Community Board

- 6. The two Banks Peninsula Community Boards, Akaroa/Wairewa Community Board and the Lyttelton/Mt Herbert Community Board each have a total of six members, comprising five elected board members and one appointed member being the Councillor representing the Banks Peninsula Ward.
- 7. It should be noted that Community Boards elect their own chairperson. If the Council wishes to appoint Councillors as members of the Community Boards then an appropriate resolution would be:

"That the Council appoint to the respective Community Boards the two Councillors from the wards which are situated in each of the Burwood/Pegasus, Hagley/Ferrymead, Fendalton/Waimairi, Riccarton/Wigram, Shirley/Papanui, Spreydon/Heathcote communities and the Councillor from the Banks Peninsula Ward to the Akaroa/Waiwera and Lyttelton/Mt Herbert Community Boards."
