11. McCORKINDALE PLACE - PROPOSED NO STOPPING RESTRICTIONS

The Board considered a report seeking approval to install no stopping restrictions at the intersection of Golf Links Road and McCorkindale Place.

The Board **resolved** to approve prohibiting the stopping of vehicles at any time:

- (a) On the west side of Golf Links Road commencing at its intersection with McCorkindale Place and extending in a southerly direction for a distance of 15 metres.
- (b) On the south side of McCorkindale Place commencing at its intersection with Golf Links Road and extending in a westerly direction for a distance of 15 metres.

- (c) On the west side of Golf Links Road commencing at its intersection with McCorkindale Place and extending in a northerly direction for a distance of 15 metres.
- (d) On the north side of McCorkindale Place commencing at its intersection with Golf Links Road and extending in a westerly direction for a distance of 15 metres.

12. COUNCIL FARMS - GRAZING LICENCE TO TUSSOCK HILLS FARM LIMITED

The Board considered a report seeking approval under delegated authority to ratify an existing arrangement by issuing a licence to Tussock Hills Farm Limited over those areas of reserve land in the Burwood/Pegasus Ward contained within the Council's farm portfolio for a period of up to five years.

After full discussion, the Board **resolved** that the report be deferred and that a joint seminar on the matter be sought with the Hagley/Ferrymead Community Board on Monday 10 September 2007 at 5.00pm and that the seminar include discussions with representatives of local grazing interests and further that any other relevant information be provided by staff at the seminar.

13. NEIGHBOURHOOD WEEK FUNDING 2007/08

The Board considered a report from the Community Engagement Adviser seeking approval of a process for deciding applications for 2007 Neighbourhood Week funding.

The Board **resolved** that an extraordinary meeting be held on Wednesday 3 October 2007 at 5pm in the Boardroom to consider the allocation of 2007 Neighbourhood Week Funding, along with any other business requiring a Board decision at that time.

14. BURWOOD PARK BOWLING CLUB (2004) INCORPORATED - LEASE RENEWAL

The Board considered a report seeking approval under delegated authority, to grant a new lease to the Burwood Park Bowling Club (2004) Incorporated of existing premises at Burwood Park.

The Board resolved:

- (a) To grant a lease pursuant to Section 54 (1) (c) of the Reserves Act 1977 to the Burwood Park Bowling Club (2004) Incorporated of approximately 4,476 metres of land at Burwood Park, for a maximum term of 33 years including renewals on the Council's standard terms and conditions for occupation of reserve land by sporting bodies.
- (b) To accept a surrender of the club's existing lease contemporaneously with the grant of the new lease.

15. ARTWORKS IN BURWOOD/PEGASUS WORKING PARTY - REPORT OF 9 AUGUST 2007

The Board **received** the meeting report and resolved to adopt the Working Party's recommendation to approve the commencement of the Welcome to New Brighton Sign project.
