#### PURPOSE OF REPORT

- 1. The purpose of this report is:
  - to seek approval for the Mayor and Councillors to attend the 2008 Local Government New Zealand Conference to be held in Rotorua from 27 to 30 July 2008; and
  - to seek the appointment of the Council's voting delegates to the Annual General Meeting.

#### EXECUTIVE SUMMARY

- 2. This year's conference will be held in Rotorua from Sunday 27 July to Wednesday 30 July 2008.
- 3. The Council usually authorises 5-6 Councillors to attend the conference. Last year, the Council gave approval for the Mayor and Councillors Graham Condon, Anna Crighton, Carole Evans, Bob Parker, Bob Shearing and Mrs Yvonne Palmer (Chairperson Shirley/Papanui Community Board) to attend the conference.
- 4. The Christchurch City Council is entitled to appoint one presiding delegate with voting rights for the Annual General Meeting and an alternate voting delegate. The Council is also entitled to have up to four additional Councillors attending being classed as viewing delegates. It is proposed that the Mayor be the presiding voting delegate with a Councillor named as the alternate voting delegate. The rules of the New Zealand Local Government Association provide that the term "delegate" includes both an elected member and an officer of a member authority.
- 5. A request has been received for the Council to approve the attendance of both Yvonne Palmer, (Zone 5 representative for Community Boards') and Mike Mora (Zone 5 deputy representative) at the conference. There is a session on working with Community Boards during the conference.
- 6. All Councillors have been supplied with a copy of the programme for this year's conference, the theme of which is *"Sustainable Communities"*. The theme carries many interpretations, and reflects the changing needs facing local government. Keynote speakers include:
  - Brian Dollery, Professor of Economics and Director, Centre for Local Government, University of New England, Armidale, New South Wales, Australia
  - Dr Judy McGregor, Equal Employment Opportunities (EEO) Commissioner with the Human Rights Commissioner
  - Simon Upton, Chairman of the OECD Round Table on Sustainable Development, responsible for a programme of climate change related to work over the next three years. A consultant with PriceWaterhouseCoopers, Mr Upton is also a Visiting Fellow at Otago University

#### FINANCIAL IMPLICATIONS

7. Registration fees of \$1,145 (including GST) will be incurred for each voting delegate/observer appointed by the Council, plus approximately \$1,000 per person for travel, accommodation and incidental costs. This expenditure can be accommodated within the provision for Mayoral/ Councillor conference attendance and travel included in the 2007/08 Annual Plan. Early registration at a reduced cost closes on 15 May 2008.

#### PURPOSE OF REPORT

1. The purpose of this report is to recommend that the Council be represented by two councillors at the FIFA u-17 Women's World Cup Draw announcement in Wellington on 1 June 2008.

#### EXECUTIVE SUMMARY

- The first ever FIFA Under-17 Women's World Cup is being held in New Zealand from 28 October to 16 November 2008. A total of 32 matches will be played at the four confirmed venues: Auckland's North Harbour Stadium, Hamilton's Waikato Stadium, Wellington Stadium and Christchurch's QEII Park.
- 3. All FIFA tournaments are run the same as the main FIFA World Cup the biggest sporting event in the world. Some 16 of the world's best footballing nations will be taking part after a qualification process involving more than 100 countries. The event also provides an opportunity to showcase New Zealand, with at least 150 territories taking the broadcasting rights and over 100 million people expected to watch the event worldwide.
- 4. Football is now the largest female sport in the world, with an estimated 40 million players participating in over 150 countries. The growth of women's football in New Zealand mirrors this trend with football being the most popular sport for New Zealand youth and every third junior player being a girl. There are around 35,000 female players in this country and the senior national team the Football Ferns have a world ranking of 23. Hosting this brand new FIFA event offers New Zealand a further opportunity to boost player numbers and raise the profile of the sport.
- 5. The u-17 new Zealand women's football team is known as the Young Football Ferns and 2008 is a landmark year for the girls.
- 6. Christchurch will host the two semi-finals and the final will be held in the North Harbour Stadium. The programme for the matches is set out below:
