PURPOSE OF REPORT

1. The purpose of this report is to recommend that the Council approve the draft *Residents' Groups and Community Interest Groups Policy* (attached) for public consultation; and to request that the Council decide whether to appoint a hearings panel for the purpose of considering submissions on the draft policy and reporting to the Council thereon.

EXECUTIVE SUMMARY

- 2. The Residents' Groups and Community Interest Groups Policy replaces the Christchurch City Council's Residents' Association Recognition Policy. A review of the Residents' Association policy was last carried out in 2001. Since that time the Local Government Act (2002) has been established and a number of changes have taken place at the Council. As part of the development of the 2006-16 LTCCP, the Council embarked on a process to more clearly define the Council's priorities including the Council's priority audiences. In this context, the current policy has been reviewed to assess whether it best meets the Council's strategic goals and objectives. The review has taken account of the Local Government Act (2002) principles, the Long Term Community Plan, Strengthening Communities Strategy (2007) and changes in the way in which Council carries out its business, including abolition and inclusion of Banks Peninsula.
- 3. The revised Policy recognises there are groups in addition to residents groups that want to be active in Council decision making processes. It also recognises that all residents' groups and community interest groups are defined by their members and are autonomous of the Council. It guides the Council's relationship with residents' groups and community interest groups and outlines Council support to encourage participation in the Council's decision making processes.
- 4. This Policy aims to strengthen the Council's position that all groups who may be affected by a pending decision or have an interest in it, have the opportunity to contribute to the decision making process if they so choose. This approach is in line with that set out in the draft *Public Participation Policy* (2008).

- 14. The purpose of this report is to recommend that the Council approve the draft *Residents' Groups and Community Interest Groups Policy* for public and stakeholder consultation over a 12-week period between 10 November 2008 and 30 January 2009. This will involve:
 - Appropriate publicity and promotion of the draft policy.
 - Meeting and discussion with all internal CCC stakeholders
 - Mail out to all known Residents Groups and Community Interest Groups
 - Public and stakeholder meetings
 - Targeted consultation with Maori organisations e.g. MKT, He Oranga Pounamu.
- 15. The results of this consultation will be analysed and a final policy will be available for Council consideration in April 2009.

STAFF RECOMMENDATION

- (a) Approve the draft *Residents' Groups and Community Interest Groups Policy* **attached** to this report for public and stakeholder consultation between 10 November 2008 and 30 January 2009 (12 weeks).

- (c) If the Council decides to hear submissions that a decision is made as to whether:
 - (i) the full Council hear the submissions on the Draft Policy; or
 - (ii) a subcommittee be appointed for this purpose and report to the Council on its recommendations.
