**Report of a meeting of the Spreydon/Heathcote Community Board  
held on Tuesday 20 July 2010 at 8.02am  
in the Board Room, Beckenham Service Centre,

**PART A – MATTERS REQUIRING A COUNCIL DECISION**

**1. NOTICE OF MOTION**

The following Notice of Motion is submitted by Karolin Potter.



“That the Spreydon/Heathcote Community Board **supports the recommendation of the Regulatory and Planning Committee** and opposes the installation of pokie machines at Addington Raceway but supports representatives of the Christchurch City Council and the Canterbury racing industry engaging in a discussion on ways that the Council can be involved in supporting the local racing industry and its successful survival and makes representations to the Council meeting of 23 July 2010 to that effect.”

**2. SPREYDON/HEATHCOTE COMMUNITY BOARD STRENGTHENING COMMUNITIES FUNDING - 2010/11 ALLOCATIONS**

While considering the Strengthening Communities Funding matrix and in particular the rental funding for Manuka Cottage, Waltham Community Cottage, Rowley House and Addington.net the Board **decided** to advise the Council that in the course of the Strengthening Communities Funding process it has become apparent that there is no consistency of rental funding and requests the Council to advise the Boards what work is being undertaken about this matter.

Further the Board recommends that the Council consider treating the rent consistently across the sector. Examples of inconsistency include Addington.net with rental coming from the Community Board; Waltham Community Cottage where rental appears not to be transparent and both Rowley House and Manuka Cottage have rental paid to third parties.
