**Closure of libraries and mobile library**

I wish to object to the above closures. As a resident of Redwood and Casebrook for the last 25 years, the libraries have been an invaluable source of information for study and leisure for all our family, young and old. They support school and community learning and must be allowed to continue. The loss of the services will severely affect residents in these communities. A library in each community is a valuable asset and contributes to the intellectual health and well-being of the city as a whole. The savings of \$450,000 cannot be justified.

**Closure of four suburban pools**

I wish to object to the closure of four suburban pools. These should be maintained at a level that complies with health and safety requirements. They are invaluable community assets and must not be allowed to deteriorate, and then closed, as happened with the Papanui Pool. Small community pools fulfill a need for leisure-time involvement by small groups. People who use the suburban pools are happy with the simple pleasures they provide compared to the bigger facilities which, despite their added attractions can be anonymous places (see comments below).

**Healthy communities mean a healthy city**

In the modern macro-economic and social global scene, sociologists now say that strong, small communities, where a sense of identity can be achieved are essential for the good health of societies. A sense of identity instilled in our young people will give them confidence and a secure base from which to expand into the wider world and be responsible citizens. The local libraries and swimming pools are part of this.

Do we really need a new pool in the north of the city? The upgrade of Jellie Park and the existing excellent facilities at QE11 and Centennial Pool surely provide amply for residents in the north of Christchurch. I would suggest that putting some of the money saved from building a new pool into existing pools and libraries will be a much healthier and sustainable option for the future health of our local communities.
