Submission to the Christchurch City Council to provide and maintain children's play equipment on the land divested to them in Country Palms Drive, Halswell.

The reason for this submission is that as per the attached map there is a lack of playground equipment in the immediate area. Council planners have advised that there are no plans or any funding available for the next five years providing for such a playground in the area, even though the subdivision has been in the planning and approval stages for some years. It is interesting to note that after discussions with Suburban Estates (the Developer) that as well as a significant amount of land being divested to the Council as part of the reserve contribution, there was also a substantial amount of cash given for the provision of playground equipment. The question really needs to be asked, why have we been told there are no funds available for this equipment?

It is important to note that this subdivision is made up of a **LARGE** proportion of younger families with pre-school and school aged children who would benefit greatly from the supply of this equipment. The community is overwhelmingly in support of this submission as per the attached petition.

While preparing the petition, it was made apparent that many families were having to travel some distance to find suitable play equipment for their children and were dissatisfied with the lack of planning and foresight from Council. Currently, the nearest playground is located in Muir Avenue. Unfortunately this playground is very secluded by a large amount of vegetation and trees and borders the busy Main Akaroa Highway. Because of it's seclusion, it is not a very safe area for younger children and is also subjected to regular vandalism as it is difficult for neighboring properties to see the equipment. The closest playground other than this is located in Rearsby Drive which only provides two swings and two see-saws. It should be noted that whilst walking to a playground could be seen as beneficial exercise, the subdivision is bordered by busy main roads which are difficult to cross, therefore a quiet area (already allocated) within the subdivision would be welcomed.


This reserved land is <u>not</u> being utilised. Our children in this area are lacking a playground that provides challenging physical activity through equipment that caters to climbing, balancing and other play necessary to provide a good level of physical exercise (as recommended by the health department's '30 Minutes a Day' advertising campaign). From feedback obtained from the community we would like to see the provision of some swings, slides and fort/climbing equipment.


Already due to a lack of social places for our children to gather and play positively, there have been incidences of vandalism and social nuisance within the subdivision, which could well have been avoided with the provision of such a playground. It would be far better for the council to be proactive in spending our high end rates money and the money already allocated through reserve contributions, in the provision of this facility rather than having to be reactive to vandalism and social issues.

Thank you for your time in considering this submission and we look forward to seeing the council's approval of this new playground which will provide a safe and social area for local children and their parents to gather and exercise.
