The Disabled Persons Centre Trust request the Christchurch City Council to allow two (2) accessible car parks on the street front at 314 Worcester St, Christchurch and additionally marked (painted) car parking on the remaining street frontage of the premises.

The Centre comprises seven organisations. Alzheimers Canterbury, Pain Action in New Zealand, Neurological Foundation Canterbury, Total Mobility Taxi Voucher scheme, Multiple Sclerosis and Parkinson's Society, Disability Information Service and New Zealand Paraplegic and Physically Disabled Foundation.


The majority of clients using the Centre are either disabled or over the age of 65. As Christchurch's population increases and ages we envisage even more use of the Centre. People utilising the Centre are in definite need of accessible parking.

The Centre runs various different groups and activities that urgently require additional parking. There is currently very little turnover of parking. Cars are parked on the street front for the whole of the working day. (Presumably) people are walking into town after leaving their cars in non fee parking spaces.

The Centre provides some parking on site – however for the aforementioned reasons we are requesting dedicated street parking.
