\*Heritage needs to become a priority in Christchurch not the developers needs -planners need to look at preservation of older buildings and CONSULTATION with the communities involved-(not an impossible task ) Tourists enjoy visiting the Avon Loop for example, with the older buildings creating an interesting character building filled area along the river. The current SAM (SPECIAL AMENITY AREAS) should be notified resource consent areas so that we do not lose our areas to unsuitable developments. Put people first NOT DEVELOPERS!!!

\*TO DECREASE SPENDING DON'T GO AHEAD WITH THE NEW COUNCIL BUILDING -concentrate on getting the problem areas of the city - transport (bus/cycling), youth, heritage and community.
