Your Submission:

1. I want the Council to:

Local Music

* Make budget provision of \$50,000 to support local music. This should include support of NZ Music Month, a Christchurch Music Awards, and funding for a local music coordinator.

* Play local music (Christchurch and New Zealand) as part of its operation of its call centre.

Capital Endowment Fund

* Amend the use of the Capital Endowment Fund to spread it evenly across Economic, Civic, and Community Projects. This should be split into three dedicated funds which have 33% of the total to distribute each. Community have missed out on this fund and that is unfair. I request that the CEF is also used to help offset the social development of city housing rather than putting rents up.

Aquatics Facility

* Bring forward budget provision to allow an aquatic facility to be built in the eastern suburbs within the next five years. If you can borrow for a new civic building, then could you please consider borrowing for a new aquatic facility?

Youth

* I submit that you should re-establish a youth council within the City Council and make budgetary provisions to do so.

* I submit that you should support youth social housing.

* I submit that you should make budgetary provision for a youth entertainment/social centre within the central city. This would be in response to the requests from both the central city revitalisation youth consultation and youth urban leisure study.
