Complexities have surfaced with developments at Bridlings Flat regarding the disposal of domestic effluent and the concerns of the long term cumulative effects on the adjacent Lake Forsyth.


The land in the area is marginal for farming practices as we know it at present, therefore it is reasonable to assume that there will be future development of a residential nature at some point.

With the sensitivities from cultural, historical and environmental arenas I strongly request the council move forward the \$40 000 allocated for the area to be spent in 2017 to this year's budget to fund a study with a strong focus on the ecological relationship between lake Forsyth and the domestic housing close to the lake.

The study which is urgently needed may be an introduction to a wider report that covers issues for the whole unique area of Little River and Kaitorete Spit.
