23.10 DRAFT PROCESS FOR BOARD DISCRETIONARY FUND ALLOCATION

The Committee was asked to consider a draft application form, which incorporated checking factors to enable monitoring of Discretionary Fund allocation.

Recommendation:

That the suggested accountability checks be adopted with a view to evaluating them at the April 1999 Board meeting, with further work to be carried out by Jane Parrett on:

- 1. Research carried out in the past, and how the Board's objectives and performance indicators were formed from that research.
- 2. Outlining the steps for processing funding applications.
- 3. Formulating guidelines to assist in making decisions on applications for funding.

It was agreed that the suggested quarterly bus trip not be included as part of the monitoring process.

23.11 REDEVELOPMENT OF HOON HAY PARK

Recommendation:

- 1. That the Board agree to the present concept plan, subject to confirmation with the Parks Unit as to how fixed the plan is.
- 2. That Chris Freeman or delegated Parks Officer be invited to attend the Community Fun Day on 14 February 1999 in order to explain the plan.

23.12 PROPOSED ROAD AND RIGHT OF WAY NAMES

The Committee considered suggested names for use at the remaining roads and rights of way at the Broadoaks subdivision.

Recommendation:

- 1. That the names Kenmure, Millway, Sandstone, Rectory, Swanton, Stonewall be approved.
- 2. That the developer be advised the Board considers the names not approved are out of keeping with the area and this was the rationale used when deciding on the names.

23.13 CHILDREN AND YOUTH OUT OF SCHOOL PROGRAMME PROJECT FUNDS

The Committee was asked to consider a request for funding a shortfall of \$2,521.65 for a Kidsfun programme at Rowley School for terms 1 and 2 of 1999. In order to allocate the balance of the Out of School Programme project funds, it was proposed a sub committee be established.

Recommendation:

- 1. That the Board allocate a further \$2,521.65 from the remaining \$20,000 of its 1998/99 Project Fund allocation for the continuation of Kidsfun for terms 1 and 2 of 1999.
- 2. That a sub committee consisting of Phil Clearwater, Sonia Gill and Sue Wells be formed to make recommendations to the Board regarding allocation of the remaining Children and Out of School Programme Project Funds.
- 3. That the Sub committee be tasked with setting a closing date for applications, setting eligibility criteria, deciding on funding priorities, and deciding on the information required from applicants.
