The purpose of this report is to seek Board approval to install a P60 parking restriction in Upland Road.

A request has been received from the owners and occupiers of Upland Road to install time restricted parking in their street. All day parking of students’ vehicles from Hillmorton High School is causing problems for residents being unable to park close to their properties, and vehicles parking closer than one metre to driveways are causing difficulties when residents turn into their properties, especially with vehicles parked on each side of the road. The residents request that:

1. Restricted parking, i.e. 8:30am to 3:30pm one hour parking during School terms be implemented. Restriction to be on the even numbered side of the road, i.e. on the right side looking from Hoon Hay Road.
2. Yellow lines be placed on the bend from No.2 towards Hoon Hay Road.
3. Kerb markings be placed at driveway entrances within the legal distance required.
4. A “No Exit” sign be re-erected under the street sign.

The request also includes a signed petition (copy attached) of support from most occupiers. Some owners have not signed because they were unaware of the petition due to their properties being rented to others. Each of the nine owners have been sent personal letters seeking their comments to the proposal. Three owners have responded in support of the proposal.

The request is for the restriction to apply to the school terms. This would be difficult to do as school terms vary from year to year. This problem was also encountered when the Canterbury University parking issue was considered. A solution to the problem was to make the restriction apply from March to October i.e. the University academic year. As the school Christmas break begins in December and ends at the beginning of February the restriction should therefore apply from February through to the end of November. The parking restriction would therefore be P60, 8:30am-3:30pm, Monday to Friday, February to November. It would apply to the north-western side of the street (see attached plan).

The ability to mark parking limit lines at each driveway with the proposed parking restriction, as per Council policy, will satisfy item 3 of their request. Items 2 and 4 have already been attended to.

Hillmorton High School is aware of the residents concerns and their request to the Council to install a parking restriction in Upland Road. I have contacted Hillmorton High School and they are happy with the residents P60 parking restriction proposal.

- Recommendations:**
1. That the parking of vehicles be restricted to a maximum period of 60 minutes, 8:30am-3:30pm, Monday to Friday, February to November on the north-western side of Upland Road, commencing at a point 8 metres from its intersection with Hoon Hay Road and extending in a southerly direction for a distance of 41 metres.
 2. That the parking of vehicles be restricted to a maximum period of 60 minutes, 8:30am-3:30pm, Monday to Friday, February to November on the north-western side of Upland Road, commencing at a point 65 metres from its intersection with Hoon Hay Road and extending in a southerly direction for a distance of 107 metres.
