FINANCE AND PLANNING COMMITTEE

2. PROJECT FUNDING ALLOCATIONS 1999/2000

At its meeting on 2 February 1999, the Board resolved that the initial consideration of projects for inclusion in the Board's 1999/00 project funding allocations be undertaken by the Committee and reported back to the Board on 2 March.

To assist the Committee in its considerations, a comprehensive report was submitted setting out details of projects that the Board had previously supported in the past along with a number of new proposals identified by members, staff and others.

It was noted that the Board again had \$250,000 of Project Funds and \$50,000 of Discretionary Funds available in which to allocate. As in past years, it was **agreed** that the discretionary budget be retained for allocation early in the 1999/00 period.

The various allocations arising from the detailed assessment of all the information submitted are listed in the recommendation which follows.

In considering the proposed provision of a footpath extension on Wairakei Road, support was expressed that the section between Stanleys and Russley Roads be a dual footpath/cycleway. The Area Engineer undertook to further investigate this option including the possibility of this section being funded in part from the cycleways budget thereby enabling the footpath only portion from Russley to Orchard Road (say \$4,000) to be funded by the Board.

Other proposals discussed in detail included the provision of a crossing facility for Aorangi School children on Aorangi Road near Colwyn Avenue and also the timing and extent of traffic calming improvements proposed in Reynolds Avenue.

On the above matters, there was general support for Board funding to be applied in part but that balance funding in each instance be sought from the City Streets Unit.

The Committee discussed the desirability of undergrounding overhead services in Poynder Avenue as part of the renewal of the kerb and channel in 1999/2000 and it was **agreed** that the City Streets Unit be requested to consider undertaking the undergrounding work at the same time.

The funding requested to enable the setting up of a youth computer club at the Bishopdale Community Centre in partnership with the Bishopdale Library was discussed and in agreeing to partially funding the initiative, the staff were asked to also investigate the use of second hand PC machines.

The application from Orana Park for funding support towards the provision of new footpaths was considered with it being noted that a total amount of \$45,000 was requested over the next three years ie: \$15,000 per year. Members acknowledged the worthiness of the proposal but with the limitation on funds available felt that at this stage a lower contribution of say \$10,000 per year was appropriate.

The various community responses were noted and staff were asked to review the requests including the possibility of support being applied from both the community funding and discretionary funding budgets.

Recommendation: That the Board's Project Funding for 1999/2000 amounting to \$250,000, be allocated as follows:

The Society had asked the Board to consider the appointment of a Board member to the judging panel and to provide some funding support towards the event.

Recommendation:

- 1. That Keith Nuttall be appointed as the Board representative on the judging panel.
- 2. That funding of up to \$500 be made available to the Merivale Precinct Society from the Neighbourhood Week budget (\$1,500).
