## 24. COMMUNITY ADVOCATE'S UPDATE

## a) GREEN OPEN SPACE SEMINAR

Chris Freeman (Parks Planning Team) and Gary Harrow (Area Parks Officer) conducted a seminar on Green Open Space in the Hagley/Ferrymead community on the 11th August 1999.

The seminar was based on research undertaken by Sarah Duffell in August 1996 detailed in a report "Local Parks Acquisition Strategy".

Chris addressed how the Parks Unit were and will be addressing the shortage of green open space as identified in that report. He talked about where they had identified areas where sections needed to be purchased. Chris also outlined the prospects of creating green open space corridors heading to the City and major parks within the area.
