The purpose of this report is to submit the outcomes of the Works and Traffic Committee meeting held on Friday 24 November 2000.

The meeting was attended by Helen Broughton, Bob Shearing, Ishwar Ganda and Mike Mora. Alison Wilkie was also present.

An apology was received from David Buist.

#### 1. DEANS AVENUE/RICCARTON AVENUE/RICCARTON ROAD INTERSECTION

At the 25 August 2000 and 27 October 2000 meetings of this Committee the design layout for the improvement works to this intersection were discussed.

The main improvement features are the doubling in size of the physical roundabout, the 'drawing back' of the traffic splitter islands/road markings on all four legs, and the physical provision of cycle lanes on Riccarton Road.

On behalf of the City Streets Unit, Bill Greenwood (Safety Auditor) was in attendance to discuss the concerns, from members, in relation to pedestrian and cycle safety.

This intersection has a bad accident record; these improvement works would greatly enhance safety for all users but would lessen its capacity.

Traffic signals, as an option for the future, would be investigated.

Following discussion, members were more appreciative of the physical constraints of this intersection being a barrier to a more complete configuration to being constructed; these improvement works were acknowledged as a positive move towards greater safety for all users.

#### 2. TRANSIT NEW ZEALAND, TRAFFIC ISSUES

On behalf of Transit NZ, Tony Spowart was in attendance to discuss various traffic issues with the Committee.

The Committee had invited representatives from the local Residents Groups to attend this meeting to discuss these issues. Messrs Alex Cameron, Stephen Shimmin and Trevor Herron were in attendance.
