6. COTSWOLD SCHOOL - PROPOSED P.3 PARKING AND NO-STOPPING RESTRICTIONS

The purpose of this report is to request that the Board approve the installation of a P.3. parking restriction along the frontage of the Cotswold School and a no-stopping restriction during the pickup/dropoff times for pupils at the pedestrian entrance to the school in Martbern Crescent.

BACKGROUND

A written request has been received from Cotswold School that a three minute parking restriction be installed along the Cotswold Avenue frontage of the school, to operate between the hours of 8.15 to 9.15 am and 2.30 to 3.15 pm, Monday to Friday, as shown on the **appended** plan.

The School has also requested that a No-Stopping restriction be installed on both sides of Martbern Crescent to both the north and south of the schools pedestrian entrance. The School would like the No-Stopping restriction to operate between the hours of 8.15 to 9.15 am and 2.30 to 3.15 pm, Monday to Friday. Following the School's request the residents have been surveyed. Full support has been received from the owners of the five properties whose frontages are affected, with one objection from a tenant. The requested parking restriction is shown on the accompanying sketch.

PROPOSAL

To improve the safety of children attending the school it is proposed that a P.3. parking restriction be installed along the frontage of Cotswold School and a No-Stopping restriction be installed at the School's pedestrian entrance in Martbern Crescent to operate during the times of 8.15 to 9.15 am and 2.30 to 3.15 pm, Monday to Friday.

- **Recommendation**: 1. That the parking of vehicles be restricted to a maximum period of three minutes on the east side of Cotswold Avenue commencing at a point 7.9 metres north of the southern boundary of the Cotswold School and extending in a northerly direction for a distance of 49.9 metres. This restriction to apply from 8.15 to 9.15 am and 2.30 to 3.15 pm, Monday to Friday.
 - 2. That the stopping of vehicles be prohibited on the west side of Martbern Crescent commencing at the southern boundary of No.3 and extending in a northerly direction to the common boundary of No.s 7 and 9. This restriction to apply from 8.15 to 9.15 am and 2.30 to 3.15 pm, Monday to Friday.
 - 3. That the stopping of vehicles be prohibited on the east side of Martbern Crescent commencing at the southern boundary of No.4 and extending in a northerly direction to the common boundary of No.s 12 and 14. This restriction to apply from 8.15 to 9.15 am and 2.30 to 3.15 pm, Monday to Friday.

Chairman'sRecommendation:That the foregoing recommendations be adopted.
