## 24. COMMUNITY ADVOCATE'S UPDATE

## (a) BROOKHAVEN ISSUES – LETTER MR G M BENNETT

Mr G M Bennett wrote to the Chairperson on 12 November 1999 (acknowledged 24 November 1999 by Chair) and again on the 8 December 1999 following the chair's acknowledgement.

Both of these letters were passed on to me for appropriate action.

Many of the issues raised by Mr Bennett are complex and will be the subject of various Council Units' input.

Issues raised by Mr Bennett are:

- (a) Dyers Road
  - Drainage
  - Landscaping
  - Stability
  - Safety (speed limit 70km with no footpath)
  - Heavy traffic vibration
  - Noise
- (b) Linwood Avenue
  - Tree planting
    - beautification
    - wind protection from easterly for Brookhaven
  - Use by Surveyors (True)
- (c) Lack of bus service for or within Brookhaven Estate
- (d) Forming of a Residents' Association

I have sent copies of Mr Bennett's letters and Board members' questions to the appropriate Business Units for a report.

I am requesting that the report be available for the March meeting of the Board. Mr Bennett will be notified accordingly and the Board report will be forwarded to him.
