

## 5. CORRESPONDENCE

### 5.1 CLAREVALE RESERVE - PLAY EQUIPMENT

The following letter was received from Jack Wilkie regarding the relocation of play equipment in Clarevale Reserve:

### 5.2 NEW WOOLSTON/BURWOOD EXPRESSWAY BRIDGE

The following letter was received from Irene Scott, Avondale Residents’ Association regarding the new Woolston/Burwood Expressway bridge:

*“At our meeting held on 11 May 2000, the Association proposed that the new Expressway bridge should be named ANZAC Bridge to correspond with ANZAC Drive of which it forms a part. Further we would like all of this section of the Expressway to adopt this name, ANZAC Drive to provide continuity.*

*We see that there was a proposal to name the bridge Queens Avon Bridge and the new road be called Queensbridge. We feel this could be confused with Queenspark if the adjoining suburb adopted the name. A brainstorming session with our members came up with Brookvale, Brookleigh, Corserdale and Riverleigh for the suburb. As we know, in the area, Avondale is regularly confused with Avonhead and sometimes Avonside as well. I hope these suggestions will be taken in the spirit they are offered and good luck with the selection process.”*

#### **Chairperson’s**

- Recommendations:**
1. That the Avondale Residents’ Association be advised that the name ANZAC Drive has been approved from Travis Road to Wainoni Road.
  2. That the Board recommend that the bridge be named ANZAC Bridge.
  3. That the Avondale suburb renaming be referred to the Suburbs Subcommittee.

### 5.3 FLUORESCENT YELLOW SCHOOL SIGNS

The following letter was received from Betty Chapman, Marshland Primary School, regarding the installation of a fluorescent school sign:

*“On behalf of the Board, staff and parents of Marshland School, I would like to thank you for providing a fluorescent school sign on Prestons Road on the Redwood side of our school. We have had very positive feedback as a result of this sign, and the one put up by the Papanui Ward, as they give motorists approaching from Redwood a much clearer indication that they are approaching a school.*

*In view of the success of the signs, we are wondering if allowance could be made in your next budget for providing similar signs on the Marshland Road side of our school, to warn motorists turning into Prestons Road at the roundabout.*

*As you know, we have been very concerned for a long time about the 80 km/h speed limit outside our school, and anything that can be done to help reduce the risk of accidents to our children would be extremely welcome.*

*Once again, many thanks for the sign that has been provided, and we hope for a favourable response to our request for further signs in the near future.”*

#### **Chairperson’s**

**Recommendation:** That the Board fund the additional signage from its 1999/2000 discretionary funds and that staff consult with the Shirley/Papanui Community Board for a shared cost in the funding of the two signs.
