

**8. PROPOSED ROAD STOPPING  
RETENTION OF STOPPED ROAD IN COUNCIL OWNERSHIP  
(EUREKA STREET AND CARISBROOKE STREET)**

The purpose of this report is to start the legal procedures necessary to stop a portion of legal road.

The reason for this road stopping is to stop a portion of Eureka and Carisbrooke Streets for traffic management purposes as part of the Woolston/Burwood Expressway.

Approval in principle was recommended by the City Services Committee and Burwood/Pegasus Community Board, and approved by the Council at the March meetings.

The City Streets Unit agrees with this proposal.

The proposed road stopping is not shown in the Notified City Plan.

The land is to be landscaped together with other Council land adjoining the Expressway.

**RESOLUTION**

Pursuant to the provisions of Sections 319 (h) and 342 of the Local Government Act 1974, the Christchurch City Council hereby resolves to stop these portions of road as shown on the plans and described in the Schedule hereto.

**REASON FOR THE ROAD STOPPING**

The reason for this road stopping is to legally stop formed portions of Eureka and Carisbrooke Streets to restrict vehicle access onto the Woolston/Burwood Expressway. The physical stopping of the streets will be carried out at the time of the Expressway construction.

**PURPOSE TO WHICH THE STOPPED ROAD WILL BE PUT**

The portions of road when stopped will be held by the Council in fee simple and used for landscaping purposes pursuant to Section 345 (1) (b) of the Local Government Act 1974.
