The Trust has received \$15,000 from The Community Trust and a one-off \$15,000 grant from the Christchurch City Council for the salary costs. The after school hours programme include weekend activities that are open to the whole family/whanau of the student/young person. The "educational" component of the project is being met by Aranui High School and the Ministry of Education.	\$3,000

New Brighton Residents' Association (Michael McNabb)	Contribution towards rental and operational/overhead costs for the Association to "trial/pilot" a Community Support and Information Room at Collingwood House, New Brighton.  Two members of the Association called a meeting with two Community Board members David Close and Chrissie Williams and with Advocacy Team members Dennis Morgan and Michael McNabb. The focus of the meeting was to discuss further the Association's 1999 proposal of establishing a community house type project in New Brighton. From that meeting I have begun preliminary investigations with the owners of Collingwood House and the Council's Property Unit to explore "long-term/secure" project viability and accommodation issues. In the interim I am recommending funding that covers the Association's accommodation and service overhead costs for two 10am to 1pm hours at the House. Such a grant would enable the Association to pilot this project to December 2000 and then be able to provide a "practical" report on the ongoing viability of the project. (See attachment.)	\$1,500
