#### 1. FERRYMEAD TRUST REQUEST FOR FINANCIAL ASSISTANCE

The Committee was in receipt of a request for financial assistance to the relocating of Washbourne House, an historic 1853 homestead, from Brockworth Place to Ferrymead Historic Park.

On a show of hands, five votes in favour and three against, the Committee agreed the following:

# **Recommendation:** 1. That a grant of \$3,000 be made to Ferrymead Park Limited for the relocation costs of Washbourne House.

- 2. That the grant be funded from 2000/01 Discretionary Fund.
- 3. That the Committee would receive a further application for funds if a shortfall still exists.

#### 2. CANTERBURY 150<sup>TH</sup> ANNIVERSARY CELEBRATION COMMUNITY SUPPORT FUND

The Committee were supportive of establishing a fund, which would be made available to any community group that was hosting an event as part of the provincial  $150^{\text{th}}$  year anniversary celebrations.

## **Recommendation:** 1. That an allocation of \$2,500 be made available to community groups for the $150^{\text{th}}$ anniversary celebrations.

- 2. That the approval be funded from the 2000/01 Discretionary Fund.
- 3. That the Community Affairs Committee administer the fund.
