The purpose of this report is to submit the outcomes of the Finance and Policy Committee meeting held on Thursday 8 March 2001.

The meeting was attended by Ishwar Ganda (Chairperson), Paddy Austin, Helen Broughton, Mary Corbett, Alison Wilkie, Neville Bennett, Mike Mora, David Buist and Bob Shearing.

#### 1. BOARD PROJECT AND DISCRETIONARY FUNDS 2000/01 UPDATE

The meeting considered a comprehensive review of Project and Discretionary funded projects.

As at 31 January there was \$36,497 funds available for reallocation; this would be constantly reviewed and brought back to the Board for possible (new) project funding.

Additional funding to two existing and one new project were supported.

**Recommendation:** That the Community Board approve additional funds to:

## 2. COMMUNITY BUSINESS PARTNERSHIP INITIATIVES 2000/01 PROJECT – FUNDED ITEM

This fund was established to enable the Community Board to participate in a (financial) partnership with local business owners/retailers.

Ongoing discussions have been held with the Riccarton Business Association about an enhancement programme. A recent meeting with Association representatives and (Council) Environmental and landscaping officers was very positive.

A small working party has been established to be chaired by Paddy Austin with the support of the Community Advocate.

The majority of Board members were supportive of the \$15,000 allocation being earmarked to Riccarton; it was noted that other retail/business areas may be looking for Community Board support in the future.

**Recommendation:** That the "Community Business Partnerships Initiatives" allocation be set aside for the Riccarton business area project team.

(Neville Bennett abstained from voting on this recommendation.)

## 3. 2001/02 BOARD OBJECTIVES

The Community Board have given "power to act" to this Committee to progress the 2001/02 Annual Plan process, of which the Objectives and Performance Indicators were an integral part.

The Community exercising its "power to act" agreed with the following:

### **OUTPUT: COMMUNITY WELLBEING**

#### **Description**

 To support communities to plan, organise and carry out initiatives that reflect their needs and aspirations. • To empower and enable those who are deprived of power and resources, thereby contributing to social well-being.

### Objectives for 2001/02

- 1. Supplement the capabilities and resources of community groups and structures.
- 2. Support community governance processes.
- 3. Ensure Council activities are appropriate to communities.
- 4. Advocate on issues impacting on Christchurch communities.

#### **Performance Indicators**

- 1. That at least 10 outputs from the Community Plan key strategy No 1 "supplement the capabilities and resources of community groups or structures" are met.
- 2. That at least 5 outputs from the Community Plan key strategy No 2 "support community governance processes" are met
- 3. That at least 12 outputs from the Community Plan key strategy No 3 "ensure Council activities are responsive to communities" are met.
- 4. That at least 4 outputs from the Community Plan key strategy No 4 "advocate on issues impacting on Christchurch communities" are met.

### 4. BOARD PROJECT AND DISCRETIONARY FUND ALLOCATIONS 2001/02

The Council had approved a total of \$390,000 to Community Boards for allocating in the 2001/02 year.

An extensive matrix process had been compiled, by the Sockburn Advocacy Team, and endorsed (in principle) by this Committee last November.

The matrix is based on the Council's Community Policy, the mission statement of which is now the mission statement for the Board (refer clause 3).

Full discussion ensued on the project matrix; one project was deleted, that being the "International Year of the Volunteer 2001".

Recommendations to increase the proposed Works and Traffic Committee vote (from \$30,000) to \$50,000, or \$40,000 were **lost**.

Acting under "power to act" from the Community Board, the Finance and Policy Committee **resolved** to allocate its 2001/02 Project and Discretionary Funds as follows:
