The purpose of this report is to enable the Board to review the practice of the (previous) Board structure, in terms of the establishing of committees.

The Board committees align themselves comfortably with the Community Board's "Terms of Reference, 2001/02", being (abbreviated)

- a continuing involvement in functional areas
- a policy and monitoring review
- liaison/link with the community.

Any committee structure should be, similarly, aligned to the Council's Standing Committee structure.

The previous Board established these four committees which, it would be agreed, worked very successfully.

Three of the four committees met monthly, with the Finance and Policy Committee meeting on an "as required" basis.

The current Community Board budget has financial provision for these committee meetings to be funded.

If the Board is receptive to the continuing practice of having standing committees it is suggested that a full schedule of meeting dates be established now, taking into account the schedule of meeting dates for the Community Board (refer clause 11).

## Recommendation:

- That the Community Board adopt the (Council) structure of Committees.
- 2. That the principal of aligning the Board Committees to the Council's Standing Committees be endorsed.
- 3. That the four Committees be named:
  - Finance and Policy Committee
  - Community Development Committee
  - Roading and Works Committee
  - Environment and Health Committee
- 4. That each Committee comprise four Board members, with the Chairperson being an "ex officio" member of each Committee.
- 5. That membership and Chairmanship of the Committees be determined at this meeting.
- 6. That the Board agree on a full schedule of meeting dates, for 2002, of the Committees.
